## A SECOND AMENDMENT TO AN INDEPENDENT CONTRACTOR AGREEMENT WITH JLJ CONTRACTING, INC. FOR THE CONSTRUCTION OF AN ENCLOSURE ADJACENT TO THE NORTHEAST ELEVATOR/STAIR TOWER ON THE SECOND LEVEL OF THE VILLAGE-OWNED OAK PARK RIVER FOREST HIGH SCHOOL PARKING STRUCTURE TO CHANGE THE <u>NOT-TO-EXCEED AMOUNT FROM \$76,400.00 TO \$80,050.00</u>

THIS SECOND AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT (hereinafter referred to as "Second Amendment") between the Village of Oak Park, an Illinois home rule municipal corporation, and JLJ Contracting, Inc., an Illinois corporation, is entered into this \_\_\_\_\_ day of January 2022 (collectively referred to as the "Parties").

## **RECITALS**

WHEREAS, the Parties entered into an Independent Contractor Agreement dated July 7, 2020 ("Agreement"); and

**WHEREAS,** the Parties amended Section 2 of the Agreement on November 15, 2021 to reflect a new total not to exceed amount of \$76,400; and

**WHEREAS**, the Parties seek to further amend Section 2 of the Agreement pursuant to this Second Amendment to reflect a new total not to exceed amount of \$80,050.00.

**NOW, THEREFORE,** in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **SECOND AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

The Contractor shall perform the Project in accordance with its Proposal for a price not to exceed \$76,400 \$80,050.00 ("Contract Price"). The Contractor shall complete all Work for the Project in accordance with any applicable manufacturers' warranties and in accordance with its Proposal, the Village's Request for Proposals, and this Contract, all of which, together shall constitute the "Contract Documents."

3. **OTHER PROVISIONS OF THE AGTEEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Second Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Interim Village Manager of the Village of Oak Park.
