AMENDMENT TO A FUNDING GRANT AGREEMENT BETWEEN THE VILLAGE OF OAK PARK AND BEYOND HUNGER

THIS AMENDMENT TO THE FUNDING GRANT AGREEMENT (hereinafter referred to as the "Amendment") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the "Village"), and Beyond Hunger, an Illinois not-for-profit corporation (hereinafter referred to as "Grantee") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into a Funding Grant Agreement dated August 2, 2021 ("Agreement"); and

WHEREAS, the Parties seek to amend the Agreement to substitute and replace the Scope of Services attached to the Agreement as Exhibit 2 with a new Scope of Services attached hereto and incorporated herein by reference.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
- 2. **AMENDMENT TO AGREEMENT.** The Agreement between the Parties is hereby amended to substitute and replace the Scope of Services attached to the Agreement as Exhibit 2 with a new Scope of Services attached hereto and incorporated herein by reference.
- 3. **OTHER PROVISIONS OF THE AGREEMENTS TO REMAIN IN EFFECT.** All other terms and conditions of the Agreements shall remain in full force and effect.
 - 4. **EFFECTIVE DATE.** This Amendment shall be effective as of May 3, 2022.
