

ORDINANCE

AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS TECHNOLOGY EQUIPMENT OWNED BY THE VILLAGE OF OAK PARK

WHEREAS, in the opinion of the corporate authorities of the Village of Oak Park ("Village"), it is no longer necessary or useful to, or for the best interests of the Village, to retain the technology equipment described in Section 2 below; and

WHEREAS, it is in the best interests of the Village to expeditiously dispose of the technology equipment set forth in Section 2 below pursuant to the authority granted to the Village by the Illinois Municipal Code, 65 ILCS 5/11-76-4.

NOW, THEREFORE, BE IT ORDAINED by the President and the Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated into this Ordinance and shall have the same force and effect as though fully set forth herein.

Section 2. Technology Equipment No Longer Useful to the Village. Pursuant to section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4, the Village finds that continued ownership of the technology equipment set forth in the list attached hereto and incorporated herein by reference as Exhibit A is no longer necessary or useful to the Village or for the best interests of the Village to retain ownership.

Section 3. Sale and Donation of Technology Equipment. All Apple devices set forth in Exhibit A shall be sold "as-is" by the Village to Phobio.com upon the execution of the Bill of Sale attached hereto and incorporated herein by reference as Exhibit B. The remaining electronic equipment set forth in Exhibit A shall be donated to PCsForPeople.com, a 501(c)(3) non-profit corporation, who shall refurbish the equipment and distribute it to low income communities or recycle the equipment at no cost to the Village.

Section 4. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of Oak Park are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
