RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT BETWEEN

THE VILLAGE OF OAK PARK AND ADVANCED SECURITY SOLUTIONS INC IN AN AMOUNT NOT

TO EXCEED \$564,902.40 FOR SECURITY SERVICES AT VILLAGE PARKING STRUCTURES AND NOT

TO EXCEED \$55,000 FOR SECURITY SERVICES AT VILLAGE HALL FOR A ONE YEAR PERIOD

THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and Advanced Security Solutions Inc, an Illinois corporation (hereinafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated July 28, 2020 ("Agreement"); and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$619,902.40, which includes \$564,902.40 for services at Village parking structures and \$55,000 for security services at Village Hall, for the period of August 1, 2021 through July 31, 2022.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. RECITALS INCORPORATED. The above recitals are incorporated herein as though fully set forth.
- 2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement through July 31, 2022.
- OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT. All other terms and conditions of the Agreement shall remain in full force and effect.
- 4. **EFFECTIVE DATE.** This Renewal shall be effective on the date of its execution by the Village Manager of the Village of Oak Park.
