**RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN THE
VILLAGE OF OAK PARK AND THOMPSON ELEVATOR INSPECTION SERVICE, INCORPORATED
IN AN AMOUNT NOT TO EXCEED \$50,000**

THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and Thompson Elevator Inspection Service Incorporated (hereinafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated December 3, 2019 ("Agreement"); and,

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement and the Contractor's Proposal and Schedule of Fees (collectively referred to as "Proposal"), attached hereto and incorporated herein by reference, in an amount not to exceed \$50,000.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement from the date of execution of this renewal through December 31, 2022.






