

**RENEWAL OF THE PROFESSIONAL SERVICE AGREEMENT BETWEEN THE VILLAGE OF OAK PARK
AND S.W. SCHMITZ, LLC, D/B/A AUTOMATIC CONTROL SERVICE FOR SCADA INTEGRATION
SERVICES IN AN AMOUNT NOT TO EXCEED \$75,000.00**

THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT (hereinafter referred to as the “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter referred to as the “Village”), and S.W. Schmitz LLC d/b/a Automatic Control Services, (hereinafter referred to as the “Contractor”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

RECITALS

WHEREAS, the Parties previously entered into a Professional Service Agreement dated January 6, 2021 (“Agreement”); and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$75,000.00.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement for an additional one (1) year term beginning on January 1, 2023 and ending on December 31, 2023.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective as of January 1, 2023
