AMENDMENT TO THE AGREEMENT FOR PUBLIC HEALTH NURSE SERVICES WITH VERONICA STANTON, R.N., TO CHANGE THE NOT TO EXCEED AMOUNT FROM \$24,000 TO \$60,000 AND EXTENDING THE TERM TO DECEMBER 31, 2023

THIS AMENDMENT ("AMENDMENT") TO THE AGREEMENT FOR PUBLIC HEALTH NURSE SERVICES dated January 1, 2023, between the Village of Oak Park, an Illinois home rule municipal corporation, and Veronica Stanton, R.N., is entered into this _____day of June, 2023 (collectively referred to as the "Parties").

WITNESSETH:

WHEREAS, the Parties entered into an Agreement for Public Health Nurse Services ("Agreement"); and

WHEREAS, the Parties seek to amend Section 3.1 and 4.1 of the Agreement to reflect an increase in the not to exceed amount from \$24,000 to \$60,000 and extend the term of December 31, 2023.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
- 2. **AMENDMENT TO AGREEMENT**. Section 3.1 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

The Village will compensate the Contractor at the rate of \$50 per hour for services provided by the Contractor during the term of this Agreement. The total amount of compensation to be paid under this Agreement shall not exceed \$24,000 \$60,000.

3. AMENDMENT TO AGREEMENT. Section 4.1 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

The Contractor shall provide the services set forth in this Agreement to begin on the last date of the execution of this Agreement as reflected below through July 31 December 31, 2023.

4. **OTHER PROVISIONS OF THE AGREEMNET TO REMAIN IN EFFECT**. All other terms and conditions of the Agreement shall remain in full force and effect.

5. **EFFECTIVE DATE**. This Amendment shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
