ORDINANCE

AN ORDINANCE AMENDING CHAPTER 7 ("BUILDINGS") OF THE OAK PARK VILLAGE CODE TO ADOPT A NEW ARTICLE 16 ("ENERGY CODE") TO ADOPT THE 2021 INTERNATIONAL ENERGY CONSERVATION CODE

WHEREAS, the Village of Oak Park ("Village") is a home rule unit of government as provided by the provisions of Article VII, Section 16 of the Illinois Constitution of 1970; and

WHEREAS, pursuant to the authority granted by Section 11-30-1 *et seq.* of the Illinois Municipal Code, 65 ILCS 5/11-30-1 *et seq.*, and pursuant to its home rule powers, the Village has determined to adopt 2021 International Energy Conservation Code as set forth in this Ordinance; and

WHEREAS, pursuant to the Municipal Adoption of Codes and Records Act, 50 ILCS 220/0.01 *et seq.* (hereinafter referred to as the "Act"), the Village is authorized to adopt by reference any code, as that term is defined in the Act; and

WHEREAS, the 2021 International Energy Conservation Code (hereinafter referred to as the "ISPSC") is a code as defined in the Act and the Code has been available for viewing as required by the Act and pursuant to Section 1-2-3.1 of the Illinois Municipal Code, 65 ILCS 5/1-2-3.1.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

- **Section 1. Recitals Incorporated.** The above recitals are incorporated herein by reference as though fully set forth.
- **Section 2. Village Code Adoption.** Chapter 7 ("Buildings"), Article 13 ("Energy Code"), Section 7-13-1 ("Adoption") of the Oak Park Village Code is adopting the language as follows:

7-3-1: ADOPTION:

A. The 2017 2021 International Energy Conservation Code, as published by the International Code Council, is hereby adopted by the Village by reference and is made a part hereof as if fully set forth in this section with the additions, insertions, deletions and changes set forth in section 7-13-2 of this article. To the extent that the provisions of the IMC are inconsistent with any codes previously adopted by the Village by reference, the provisions of the 2021 IECC shall govern unless specifically set forth in this code. In the event of a conflict between any provisions of the IMC and any provision of the Oak Park Village Code, the provisions of the Oak Park Village Code shall govern.

B.	There shall be three (3) copies of the IEBC kept on file for public inspection in the office
of the	Village Clerk Chief Building Official.

- Section 3. Identification of Ordinance with the Illinois Capital Development Board. This Ordinance shall be identified on the Internet by the Illinois Capital Development Board or any successor agency of the State of Illinois pursuant to Section 1-2-3.1 of the Illinois Municipal Code, 65 ILCS 5/1-2-3.1.
- **Section 4. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.
- **Section 5. Effective Date.** This ordinance shall be accepted at the time of adoption and will be in full force and effect after its passage, approval and publication January 1, 2024.
