ORDINANCE

AN ORDINANCE AMENDING CHAPTER 3 ("ALCOHOLIC LIQUOR DEALERS"), ARTICLE 8 ("LIST OF LICENSES FOR EACH LICENSE CLASS"), SECTION 3-8-1 ("NUMBER OF LICENSES TO BE ISSUED PER LICENSE CLASS") AND SECTION 3-8-2 ("LICENSES BY NAME AND ADDRESS PER LICENSE") OF THE OAK PARK VILLAGE CODE TO REMOVE CERTAIN BUSINESSES

WHEREAS, the Village of Oak Park ("Village") is a home rule unit of government as provided by the provisions of Article VII, Section 6 of the Illinois Constitution of 1970; and

WHEREAS, as a home rule unit of government, the Village is expressly empowered to perform any function pertaining to its government and affairs, including, but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; and

WHEREAS, due to the ceasing of operations of OMG! Brunch & Boutique, LLC, DBA OMG! Brunch & Boutique at 100 S. Oak Park Avenue, Original Pizza, LLC Series Oak Park, DBA Leona's Pizzeria at 848 Madison Street, La Majada Restaurant at 226 Harrison Street and Dominick's Finer Foods, LLC, DBA Dominick's #1124 at 259 Lake Street, it is necessary to amend the Village Code to remove these businesses liquor licensees from the Code; and

WHEREAS, at its March 24, 2015 meeting, the Village's Local Liquor Control Review Board unanimously recommended that the proposed Ordinance be adopted; and

WHEREAS, the Board of Trustees agrees with the recommendation of the Local Liquor Control Review Board and finds that it is in the best interests of the Village to amend the Village Code as set forth herein.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein by reference as though fully set forth.

Section 2. Village Code Amended. Chapter 3 ("Alcoholic Liquor Dealers"), Article 8 ("List of Licenses for Each Class"), Section 3-8-1 ("Number of Licenses to be Issued per License Class") and Section 3-8-2 ("Licenses by Name and Address Per License") of the Oak Park Village Code are amended by deleting the overstricken language and adding the underlined language to read as follows:

3-8-1 NUMBER OF LICENSES TO BE ISSUED PER LICENSE CLASS:

B-1 No more than fourteen (14) thirteen (13) class B-1 licenses shall be issued.

B-4 No more than sixteen (16) fourteen (14) class B-4 licenses shall be issued.

C-1 No more than nine (9) eight (8) class C-1 licenses shall be issued.
