ORDINANCE

AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO OPERATE A HEALTH, ATHLETIC, RECREATION AND AMUSEMENT FACILITY IN THE B-4 DOWNTOWN BUSINESS DISTRICT AT 1136 LAKE STREET

WHEREAS, at its meeting of July 18, 2016, the Board of Trustees of the Village of Oak Park ("Village") referred to the Zoning Board of Appeals for public hearing an application for a special use permit filed by S&G Bender, LLC ("Petitioner") requesting the issuance of a special use permit to operate a health, athletic, recreational and amusement facility in the B-4 Downtown Business District to be known as Spenga Fitness at the property commonly known as 1136 Lake Street, Oak Park, Illinois ("Subject Property"); and

WHEREAS, at a meeting held on August 3, 2016, the Zoning Board of Appeals held a public hearing on the Petitioner's application for the special use permit; and

WHEREAS, notice of the public hearing was duly published in the *Wednesday Journal* on June 29, 2016; and

WHEREAS, the Zoning Board of Appeals recommended that the special use permit be granted by a vote of six (6) in favor and zero (0) against; and

WHEREAS, the Zoning Board of Appeals adopted its written Findings and Recommendation on the application at its meeting of August 3, 2016, which is attached hereto and incorporated herein as <u>Attachment A</u>; and

WHEREAS, the President and Board of Trustees have received the Findings and Recommendation of the Zoning Board of Appeals with respect to the application for the special use permit at the Subject Property; and

WHEREAS, the President and Board of Trustees have determined that the granting of the special use permit for the use set forth in the Petitioner's application is in the best interests of the Village subject to the terms and conditions set forth in the Findings and Recommendations of the Zoning Board of Appeals and this Ordinance.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein by reference as though fully set forth.

Section 2. Special Use Permit Granted. The Petitioner's application for a special use permit in the B-4 Downtown Business District to operate a health, athletic, recreation and

amusement facility at the Subject Property to be known as Spenga Fitness is granted, subject to the terms and conditions set forth in <u>Attachment A</u> and this Ordinance.

Section 3. Execution of Ordinance. As a condition of the special use permit granted herein, this Ordinance shall be executed by the Petitioner to signify its agreement to the terms hereof.

Section 4. Violation of Conditions. Any violation of (i) any term of condition set forth in this Ordinance or (ii) any applicable code, ordinance, or regulation of the Village shall be grounds for the immediate rescission by the Board of Trustees of the approval granted pursuant to this Ordinance.

Section 5. Severability and Repeal of Inconsistent Ordinances. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 6. Effective Date. This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
