## **ORDINANCE**

## THE VILLAGE OF OAK PARK'S TAX YEAR 2016 PROPERTY TAX LEVY ORDINANCE

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Budget Adoption.** On December 5, 2016, the President and Board of Trustees of the Village of Oak Park ("Village") adopted its annual budget ordinance providing for a total budget for all corporate purposes legally made to be collected from the tax levy of the 2016 property tax year in the amount of \$38,989,489, for the Village's fiscal year beginning on the 1st day of January, 2017, and ending on the 31st day of December, 2017 ("Fiscal Year 2017").

Section 2. Funds Subject To Tax Levy. The sum of \$38,989,489, being the total of budget heretofore legally made which are to be collected from the property tax year 2016 for the 2017 fiscal year of the Village for all corporate purposes of the Village, for purposes of providing for a Police Pension Fund, Firemen's Pension Fund, Public Library Fund, Bond and Interest Fund, and General Fund, as budgeted for the 2017 fiscal year, shall be levied upon all of the taxable property in the Village subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein by being placed in separate columns under the heading "To Be Raised by Tax Levy" which appears over the same, the tax so levied being for the current fiscal year of said Village, and for said budget to be collected from said tax levy, the total of which has been ascertained as aforesaid and being as follows:

**Section 3. Total Tax Levy.** The total amount of \$38,989,489, ascertained as aforesaid, be, and the same is hereby levied and assessed on all property subject to taxation within the Village of Oak Park according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.

**Section 4. Conflict with Applicable Law.** This levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*, and other

applicable law, provided, however, any tax rate limitation or any other substantive limitations as to tax levies in the Illinois Municipal Code or other applicable law in conflict with the provisions of this Ordinance shall not be applicable pursuant to the Village's home rule powers as provided by Section 6 of Article VI of the Constitution of the State of Illinois.

**Section 5. Certification to Cook County Clerk.** There is hereby certified to the County Clerk of Cook County, Illinois ("Cook County Clerk"), the several sums aforesaid, constituting said total amount of \$38,989,489, said total amount the Village of Oak Park requires to be raised by taxation for the 2017 fiscal year of said Village, and the Village shall cause a certified copy of this Ordinance to be filed with the Cook County Clerk.

**Section 6. Bond and Interest Tax Levy.** The Village's bond and interest tax levy for the 2016 tax year are as follows:

**Section 9. Severability and Repeal of Inconsistent Ordinances**. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 10. Effective Date.** This Ordinance shall take effect and be in full force and effect immediately on its passage, approval and publication as provided by law.
