

**AMENDMENT TO THE INTERGOVERNMENTAL LICENSE AGREEMENT BETWEEN
THE VILLAGE OF OAK PARK AND THE FOREST PRESERVE DISTRICT OF COOK COUNTY**

THIS AMENDMENT TO THE INTERGOVERNMENTAL LICENSE AGREEMENT DATED JULY 21, 2014, between the Village of Oak Park (hereafter referred to as "Village"), an Illinois home rule municipal corporation, and the Forest Preserve District of Cook County, Illinois (hereafter referred to as "District"), an Illinois special district pursuant to 70 ILCS 810/0.01 *et seq.* (collectively referred to as the "Parties").

WITNESSETH:

WHEREAS, the Parties entered into an Intergovernmental License Agreement dated July 21, 2014 ("Agreement"); and

WHEREAS, the Parties seek to amend the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. AMENDMENT TO AGREEMENT. Exhibit A to the Agreement is hereby replaced and superseded by the Exhibit A attached hereto and incorporated herein by reference to provide additional property for use by the Village at the District's Central Compound.

2. AMENDMENT TO AGREEMENT. Section 2.1 of the Agreement is amended by adding the underlined language and deleting the overstricken language to read as follows:

2.1. The District is hereby granted a license from the Village to use ~~fifteen (15)~~ thirty (30) parking spaces in the Village's Lot Number 18 ("Village Parking Spaces"), commonly known as the Holley Court Parking Garage ("Lot 18"), for the purpose of parking District motor pool passenger vehicles for the term of this License.

3. OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT. All other terms and conditions of the Agreement shall remain in full force and effect.

4. EFFECTIVE DATE. This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
