## <u>AN ORDINANCE APPROVING THE VILLAGE OF OAK PARK'S NEW OFFICIAL ZONING MAP</u>

<b>WHEREAS</b> , the Village of Oak Park ("Village") is required to approve a map showing "the	he

pursuant to 65 ILCS 5/11-13-19, as the official zoning map of the Village; and	

WHEREAS, on \_\_\_\_\_\_\_, 2017, the Corporate Authorities of the Village adopted a new Village of Oak Park Zoning Ordinance ("New Zoning Ordinance") pursuant to Ordinance Number 17-225; and

WHEREAS, consistent with the New Zoning Ordinance, the Corporate Authorities of the Village had determined to adopt a new Village "Zoning Map," attached hereto and incorporated herein by reference; and

**WHEREAS**, the attached Zoning Map shows the Village's uses, divisions, restrictions, regulations and classifications of property within the corporate limits of the Village pursuant to the New Zoning Ordinance; and

WHEREAS, pursuant to this Ordinance, the Village's corporate authorities approves and adopts the attached Zoning Map as the Village's official zoning map as required by law and consistent with the Village's New Zoning Ordinance.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Illinois, in the exercise of their home rule powers, as follows:

- **Section 1. Recitals Incorporated.** The above recitals are incorporated herein as though fully set forth.
- **Section 2.** Approval and Adoption of Map. The Corporate Authorities of the Village approve and adopt the "Zoning Map," attached hereto and incorporated herein by reference, as the official zoning map of the Village pursuant to 65 ILCS 5/11-13-19.
- **Section 3. Severability and Repeal of Inconsistent Resolutions, Motions and Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All resolutions, motions and ordinances in conflict herewith are hereby repealed to the extent of such conflict.
