RESOLUTION

A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT FOR ASSESSMENT OF FAIR HOUSING WITH THE CHICAGO METROPOLITAN AGENCY FOR PLANNING AND AN INTERGOVERNMENTAL MEMORANDUM OF UNDERSTANDING FOR A REGIONAL ASSESSMENT OF FAIR HOUSING AND AUTHORIZING THEIR EXECUTION

WHEREAS, the Village of Oak Park is an Entitlement Community under the Housing and Community Development Act of 1974, as amended, and is therefore eligible to receive Community Development Block Grant (CDBG) and Emergency Solutions Grant (ESG) funds from the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, in order to receive these grant funds, the Village must submit an Assessment of Fair Housing (AFH), which replaces the Analysis of Impediments to Fair Housing Choice, to HUD by January 5, 2020; and

WHEREAS, HUD encourages local entities to collaborate on a regional AFH, and because collaboration offers potential benefits such as being able to more efficiently and effectively meet federal fair housing requirements and realize a cost-savings; and

WHEREAS, the Chicago Metropolitan Agency for Planning (CMAP), the official regional planning organization for Cook and other counties and municipalities in northeastern Illinois, has requested that the Village join such a regional collaboration, with Cook County government being the lead agency for this initiative.

NOW THEREFORE, BE IT RESOLVED by the President and the Board of Trustees, in the exercise of their home rule powers, as follows:

- **Section 1. Recitals Incorporated.** The above recitals are incorporated herein as though fully set forth.
- Section 2. Approval and Execution of the Intergovernmental Agreement for Assessment of Fair Housing with the Chicago Metropolitan Agency for Planning. The Intergovernmental Agreement for Assessment of Fair Housing with the Chicago Metropolitan Agency for Planning, attached hereto and incorporated herein by reference, is approved at a total cost of \$3,500, to be paid with CDBG Administration funds, and the Village Manager is authorized to execute the Agreement in substantially the form attached.
- Section 3. Approval and Execution of the Intergovernmental Memorandum of Understanding for the 2020-2024 Assessment of Fair Housing. The Intergovernmental Memorandum of Understanding for the 2020-2024 Assessment of Fair Housing, attached hereto and incorporated herein by reference, is approved and the Village Manager is authorized to execute the Agreement in substantially the form attached.

Section 4. Severability and Repeal of Inconsistent Resolutions, Motions and Ordinances. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution. All resolutions, motions and ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. Effective Date. This Resolution shall be in full force and effect immediately after its passage and approval as provided by law.
