

## **ORDINANCE**

### **AN ORDINANCE AMENDING SECTION 15-1-14 ("PROHIBITED TURN LOCATIONS") OF THE OAK PARK VILLAGE CODE TO PROHIBIT LEFT TURNS FOR NORTHBOUND TRAFFIC ON MAPLE AVENUE AT LAKE STREET**

**WHEREAS**, the Village of Oak Park ("Village") is a home rule unit of government as provided by the provisions of Article VII, Section 6 of the Illinois Constitution of 1970; and

**WHEREAS**, as a home rule unit of government, the Village is expressly empowered to perform any function pertaining to its government and affairs, including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare; and

**WHEREAS**, pursuant to the Illinois Municipal Code, Section 11-304 of the Illinois Vehicle Code, 625 ILCS 5/11-304, and Section 15-1-14 ("Prohibited Turn Locations") of the Oak Park Village Code, the Village is authorized to prohibit turns upon roadways under its jurisdiction in order to regulate, warn and guide traffic; and

**WHEREAS**, the Village has determined that it is necessary and reasonable and in the best interests of the citizens of the Village to prohibit turns for northbound traffic on Maple Street at Lake Street.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Recitals Incorporated.** The above recitals are incorporated herein as though fully set forth.

**Section 2. Village Code Amended.** Chapter 15 ("Motor Vehicles and Traffic"), Article 1 ("In General"), Section 15-1-14 ("Prohibited Turn Locations:") of the Oak Park Village Code is hereby amended to add the underlined language to read as follows:

#### **15-1-14: PROHIBITED TURN LOCATIONS:**

A. Left turns are prohibited at the following locations:

1. Westbound traffic exiting onto Oak Park Avenue from east-west alley lying midblock between and parallel to North Boulevard and Lake Street.
2. Northbound or southbound traffic on Austin Boulevard at the intersection of South Boulevard from four o'clock (4:00) P.M. to six o'clock (6:00) P.M. only, except Saturdays, Sundays and holidays.
3. Westbound traffic on North Boulevard at Ridgeland Avenue.

4. Westbound traffic exiting onto Humphrey Avenue from the east-west alley lying south of and parallel to South Boulevard.
5. Southbound traffic on Harlem Avenue at South Boulevard.
6. Westbound traffic on Westgate at Harlem Avenue.
7. Northbound and southbound traffic on Grove Avenue at Jackson Boulevard.
8. Northbound traffic on Harlem Avenue at Jackson Boulevard from seven o'clock (7:00) A.M. to nine o'clock (9:00) A.M. and from four o'clock (4:00) P.M. to six o'clock (6:00) P.M. only.
9. Northbound Austin Boulevard onto westbound Greenfield Street.
10. From northbound Oak Park Avenue onto westbound LeMoyne Street between the hours of seven o'clock (7:00) A.M. to nine o'clock (9:00) A.M. and four o'clock (4:00) P.M. to six o'clock (6:00) P.M. Monday through Friday.
11. From southbound Oak Park Avenue onto eastbound Superior Street between the hours of seven o'clock (7:00) A.M. to nine o'clock (9:00) A.M. and four o'clock (4:00) P.M. to six o'clock (6:00) P.M. Monday through Friday.
12. Southbound traffic on Oak Park Avenue at Randolph Street.
13. Westbound traffic on Randolph Street at Oak Park Avenue.
14. Southbound traffic on Harlem Avenue at Westgate Street.
15. Northbound traffic on Maple Avenue at Lake Street.

B. Right turns only are permitted at the following locations:

1. For eastbound traffic on Superior Street at Austin Boulevard.
2. For westbound traffic on LeMoyne Street onto Oak Park Avenue.
3. For northbound traffic on Humphrey Avenue at Division Street.
4. For northbound traffic on Taylor Avenue at Division Street.
5. For eastbound traffic on Harvard Street at Austin Boulevard.
6. For southbound traffic on Forest Avenue at Ontario Street.

7. For eastbound traffic on Greenfield Street at Ridgeland Avenue.
8. For eastbound traffic exiting onto Ridgeland Avenue from the Northridge Shopping Center driveway located on the west side of Ridgeland Avenue approximately twenty feet (20') south of North Avenue.
9. For westbound traffic on North Boulevard at Harlem Avenue.
10. For westbound traffic exiting onto Rossell Avenue from the parking lot located on the southeast corner of Rossell Avenue and North Avenue.
11. For southbound traffic on Euclid Avenue at Washington Boulevard.
12. For northbound and southbound traffic on Kenilworth Avenue at Washington Boulevard.
13. For northbound and southbound traffic on Wisconsin Avenue at Washington Boulevard.
14. For eastbound traffic on Randolph Street at Oak Park Avenue.
15. For northbound traffic on Scoville Avenue at Washington Boulevard between the hours of seven o'clock (7:00) A.M. to nine o'clock (9:00) A.M. and two o'clock (2:00) P.M. to four o'clock (4:00) P.M. Monday through Friday.
16. For westbound traffic exiting onto Ridgeland Avenue from the east-west alley lying immediately north of and parallel to Madison Street.
17. For eastbound traffic exiting onto Euclid Avenue from the CVS Pharmacy driveway located on the west side of Euclid Avenue approximately eighty five feet (85') north of Roosevelt Road.
18. For westbound traffic exiting onto Oak Park Avenue from the CVS Pharmacy driveway located on the east side of Oak Park Avenue approximately one hundred feet (100') north of Roosevelt Road.

C. No turns are permitted at the following locations:

1. For northbound and southbound traffic on Austin Boulevard into Superior Street in Oak Park.
2. For northbound and southbound traffic on Austin Boulevard into Harvard Street in Oak Park.
3. For northbound and southbound traffic on Ridgeland Avenue into North Boulevard.

D. Right turns are prohibited at the following locations:

1. For traffic exiting from the parking lot located at the northwest corner of Austin Boulevard and Jackson Boulevard into the north-south alley adjacent to said lot.
2. For traffic exiting from the parking lot adjacent to Fair Oaks Pharmacy, 400 Chicago Avenue, into the north-south alley adjacent to the parking lot.
3. For southbound traffic on Humphrey Avenue at Ontario Street.
4. For eastbound traffic on Division Street at Elmwood Avenue between the hours of seven o'clock (7:00) A.M. to nine o'clock (9:00) A.M. and four o'clock (4:00) P.M. to six o'clock (6:00) P.M. Monday through Friday.
5. For eastbound traffic on North Avenue at Grove Avenue between the hours of seven o'clock (7:00) A.M. to nine o'clock (9:00) A.M. and four o'clock (4:00) P.M. to six o'clock (6:00) P.M. Monday through Friday.

E. All traffic is prohibited:

1. From proceeding on Maple Avenue in a southbound direction past the barrier peninsula traffic diverter located approximately two hundred fifty feet (250') south of Monroe Street.

**Section 3. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.
