To date, there have been a total of 24 calls for service. This number is lower than 2016 when the department responded to 33 calls. The greatest number of calls for service continues to be for the recovery of stolen property by outside agencies who have located property thru utilizing the services of LeadsOnline.

The Oak Park Police Department's use of the LeadsOnline database allows officers to track pawn shop transactions electronically eliminating the need for paper copies. Officers can search for property and suspects faster and more efficiently.

I have attached the 2016 report for comparison. Although there were a number of police calls for service other than the recovery of stolen property, no enforcement action was taken by this police department against any of the listed businesses.

To date, there have been a total of 33 calls for service. This number is slightly higher than 2015 when the department responded to 28 calls. The greatest number of calls for service continues to be for the recovery of stolen property by outside agencies who have located property thru utilizing the services of LeadsOnline.

All three of the businesses have been late in submitting the daily reports. Cash America Inc. consistently fails to submit the report on time as prescribed in state law and by local ordinance. Joseph Jenks, Manager of Cash America Inc. stated that the company's Oak Park location is the only store not submitting information electronically through LeadsOnline. Aaron Cohan manager of American Jewelers & Loan and Hollywood Pawners stated that he would be able to provide reports in a more timely fashion if he was allowed to submit them electronically.

I have attached the 2015 report for comparison. Although there were a number of police calls for service, other than the recovery of stolen property no enforcement action was taken by this police department against any of the listed businesses.
