

**RENEWAL OF AN INDEPENDENT CONTRACTOR AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND CITYESCAPE GARDEN & DESIGN, LLC  
FOR THE 2018 VILLAGE CONTAINER PLANTINGS PROGRAM  
IN AN AMOUNT NOT TO EXCEED \$70,000.00**

**THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT** (hereinafter “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the “Village”), and CityEscape Garden & Design LLC (hereinafter the “Contractor”), an Illinois Limited Liability Company, is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

**RECITALS**

**WHEREAS**, the Parties previously entered into an Independent Contractor Agreement dated February 23, 2017 (“Agreement”); and

**WHEREAS**, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$70,000.00.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement from the date of execution of this renewal through December 31, 2018.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the date of its execution by the Village Manager of the Village of Oak Park.
