

04/30/2018 Transportation Commission DRAFT meeting minutes

No non-agenda public testimony.

### **Parking Pilot Program**

The Transportation Commission discussed:

- The quantity of negative public reaction and comments to the Parking Pilot Program.
- The Commission did its due diligence in its review.
- Its concern about the Village's ability to effectively enforce the plan.
- The proposed plan being a work in progress as opposed to a final product.
- The Commission's perception about a lack of goals and direction about how to address the Parking Pilot Program.
- The perceived good components in the proposed plan.
- How best to make the many recommendations, in groups or individually.
- How best to educate the public about the new rules and regulations.

#### **1. (5.2 - 2/14) On-Street Parking, Meters/Pay-By-Plate or Space**

- Ending parking meter feeding at 6 PM or at 8 PM and the consequences of each.
- The business community's take on when to end feeding the meters.
- The business community's take on dynamic pricing for parking at meters for longer than 3 hours.

Summary of April 30, 2018 Trans Commotions and roll call votes.

#### **1. (5.2 - 2/14) On-Street Parking, Meters/Pay-By-Plate or Space**

Motion by Taylor and second by Stewart:

Approve the table as presented except that the parking meter hours should go only until 6 PM in general but staff should evaluate the need for some parking meters in certain areas of the Village to go until 8 PM.

vote = 6 YES and 0 NO - therefore the motion passes.

#### **2. (5.2 - 3/14) On-Street Parking, Daytime Restrictions**

- How the proposed daytime restrictions will affect residents.

- The pros and cons of a 3 hour parking limit.
- The situation in which the standard Oak Park vehicle sticker should be the daytime permit parking pass instead of charging an additional \$70 for the pass to legally park beyond 3 hours.

2. (5.2 - 3/14) On-Street Parking, Daytime Restrictions

Motion by Taylor and second by Eichenberger:

Approve the table as presented.

vote = 3 YES and 3 NO - therefore the motion fails.

3. (5.2 - 5/14) On-Street Parking, Permit/Pass Parking (2:30am-6am)

- The opinion that residents don't want to walk more than a couple of blocks to get to and from their parked car.
- Opening up the existing on-street overnight permit parking zones to overnight guest parking might exacerbate the existing parking problem.
- Modifying some items in this group to make it more palatable.
- Alternate means to accommodate overnight guests.
- The measures, or lack thereof, to indicate whether the program succeeds.
- Environmental concerns due to more cars coming into the pilot area.
- Overnight parking space supply versus demand.
- The fact that the intent is to not overturn the on-street overnight parking ban.
- How to attract guest parked vehicles to use the public garages.
- How to evaluate the success of this group of options.
- Placing a cap on the number of available guest parking passes issued and the number 2nd cars permits issued and night permits issued and monitor all three.

3. (5.2 - 5/14) On-Street Parking, Permit/Pass Parking (2:30am-6am)

Motion by Stewart and second by Moses:

Do not approve this table.

vote = 4 YES and 2 NO - therefore the motion passes.

3. (5.2 - 5/14) On-Street Parking, Permit/Pass Parking (2:30am-6am)

Motion by Taylor and second by Thompson:

Approve the table as presented with the caveat that Staff develop a cap on the number of available guest parking passes issued and the number 2nd cars permits issued and night permits issued and monitor all three.

vote = 4 YES and 2 NO - therefore the motion passes.

4. (5.2 - 7/14) Off-Street Parking, Paid Parking and Permit Parking

- The pros and cons of using a 3 hour parking limit.
- The need to not increase permit parking rates.

Motion by Thompson and second by Stewart:

Approve the table as presented.

vote = 5 YES and 1 NO, therefore the motion passes.

Approve the table with the left side (I don't own a car) deleted and the \$70 per year Day Permit incorporated into the price of the vehicle sticker and include the subsidies.

vote = 3 YES and 3 NO, therefore the motion fails.

- The use of warning tickets as part of the pilot program.

- The need for and ability to provide adequate enforcement of the pilot program rules and regulations.
- How often should Staff provide reports to the Commission on the status of the Parking Pilot Program as implemented.
- What information should be included in the reports.

- Privacy concerns due to the personal data that will be collected under the Parking Pilot Program.

vote = 5 YES and 1 NO, therefore the motion passes.

#### **Petition for daytime Parking Restrictions on the 500 N. Humphrey Avenue block**

- The request for 2 hour parking and its relationship to the proposed 3 hour limit as found in the Parking Pilot Program.
- Who were the predominant type of motorists that parked on the block.
- How will the two hour limit be enforced.

#### **Petition for daytime Parking Restrictions on the 500 N. Humphrey Avenue block**

Motion by Moses and second by Stewart:

Approve the installation of a 2 Hour Parking 9AM-5PM Monday-Friday restriction on the east side of the 500 N. Humphrey Avenue block (north of the cul-de-sac).

vote = 5 YES and 1 NO, therefore the motion passes.
