

**AN AMENDMENT TO A PROFESSIONAL SERVICES AGREEMENT BETWEEN
THE VILLAGE OF OAK PARK AND ALARM DETECTION SYSTEMS, INC. FOR BURGLAR AND FIRE
ALARM MAINTENANCE AND MONITORING SERVICES
IN AN AMOUNT NOT TO EXCEED \$35,000.00**

THIS AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT (hereinafter "Amendment") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and Alarm Detection Systems, Inc., an Illinois corporation approved to do business in Illinois (hereafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated May 14, 2013 ("Agreement"); and

WHEREAS, the Parties seek to amend the Agreement pursuant to the terms of the Agreement to extend the term of the Agreement to December 31, 2018 and the not to exceed amount to \$35,000.00 in fiscal year 2018.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the italicized language and deleting the overstricken language as follows:

Term: The services provided by this agreement shall be provided beginning May 21st, 2013 and shall continue through ~~May 31st, 2018~~ *December 31st, 2018*, and thereafter shall renew for successive monthly terms.

3. **AMENDMENT TO AGREEMENT.** Section 9 of the Agreement is amended by adding the italicized language and deleting the overstricken language as follows:

Cost of Services: The Village will compensate ADS at the established monthly rates as outlined in Attachment A entitled "ADS Scope of Work". The total amount of the services shall not exceed ~~\$40,000 annually~~ *\$35,000.00 in 2018*. ADS is required to monitor the amount of its invoices to ensure that the Village is not billed in excess of \$40,000.00 *\$35,000.00* for the current services as listed in

Attachment A. Any amounts invoiced in excess of ~~\$40,000.00~~ \$35,000.00 will not be paid.

3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment shall be effective on the date of its execution by the Village Manager of the Village of Oak Park.
