

## ORDINANCE

### **AN ORDINANCE ESTABLISHING PREVAILING WAGES FOR PUBLIC WORKS IN THE VILLAGE OF OAK PARK, COOK COUNTY, ILLINOIS**

**WHEREAS**, the State of Illinois has enacted the Prevailing Wage Act, 820 ILCS 130/0.01 *et seq.*, as amended (“the Act”); and

**WHEREAS**, the Act requires that the Village of Oak Park (“Village”) investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of the Village employed in performing construction of public works during the month of June of each year; and

**WHEREAS**, pursuant to the requirements of the Act, the Village has determined to adopt this Ordinance establishing prevailing wages in the Village.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Recitals Incorporated.** The above recitals are incorporated herein as though fully set forth.

**Section 2. Determination of Prevailing Wages.** To the extent and as required by the Act, the general prevailing rate of wages in the Village for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Village is hereby ascertained to be the same as the prevailing wages for construction work in the Cook County area as determined by the Department of Labor of the State of Illinois (“Department of Labor”) pursuant to the Department of Labor’s determination of prevailing wages for Cook County as of June 18, 2018, a copy of said determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

**Section 3. Prevailing Wages Applicable to Public Works.** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the Act.

**Section 4. Posting of Determination.** The Village Clerk shall publicly post or keep available for inspection by any interested party this determination of such prevailing rate of wages and any revisions of such prevailing rate of wages. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to contract specifications as required by the Act, or, if permitted by the Act, shall be referenced in the contract specifications.

**Section 5. Service of Determination.** The Village Clerk shall mail a copy of this determination to any employer and to any person or association of employees who have filed their names and addresses and have requested copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**Section 6. Filing of Determination.** The Village Clerk shall promptly file a certified copy of this Ordinance with the Department of Labor of the State of Illinois ("Department of Labor").

**Section 7. Publication of Determination.** Within thirty days after the filing with the Department of Labor, the Village shall publish on its website the following notice with a hyperlink to the Department of Labor's prevailing wage schedule attached hereto:

PLEASE TAKE NOTICE that on June 18, 2018, the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois ("Village"), adopted Ordinance No. 18-378, determining prevailing wages pursuant to 820 ILCS 130/1 *et seq.*, the Illinois "Prevailing Wage Act," which determination is now effective and that the general prevailing rate of wages in the Village for laborers, mechanics, and other workers engaged in the construction of public works coming under the jurisdiction of the Village is the same as determined by the Department of Labor of the State of Illinois for Cook County as of June 18, 2018. A copy of the full Ordinance and the Department of Labor's determination is available for inspection by any interested party in the main office of the Village, 123 Madison Street, Oak Park, Illinois 60302, and to any employer, association of employers and any person of employee or association of employees who have filed, or file their names and addresses, requesting copies of the same. **Section 8. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All existing ordinances of the Village of

Oak Park are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

**Section 9. Effective Date.** This Ordinance shall be in full force and effect from and after its passage and approval and publication as required by law.
