- 2. At the bid opening, all proposals <u>must</u> be accompanied by a proposal guaranty in the amount of 5% of the bid amount. The proposal guaranty shall be in the form of a bid bond executed by a corporate surety company or a bank cashier's check.
- The awarding authority reserves the right to waive technicalities and to reject any or all proposals as provided in Article 102.01 of the 2016 "Standard Specifications for Road and Bridge Construction," prepared by the Illinois Department of Transportation.

- The undersigned agrees to substantially complete all work by <u>June 10, 2019</u> unless additional time is granted in accordance with the specifications.



REMOVAL PLAZA CONCRETE, PAVERS & SUBGRAGE TO 12" DEPTH

SELECTIVE DEMOLITION OF LAWN, PLANTING (TREES NOT INCLUDED) AND SOIL TO 12" DEPTH

- 1.1 SUMMARY
 - A. Section includes removal of plaza concrete, pavers & subgrade to 12" depth, and selective demolition of lawn, planting (trees not included) and soil to 12" depth as well as protecting existing basement-garage waterproofing when removing overburden, as indicated and required for installation of new work required for completion of the project and as specified.
 - B. Related Work:
 - Backfilling of voids left by demolition: refer to Division 01 Section "Earthwork" and Division 31 Section "Acceptance of Backfill, Top Soil & CU Structural Soil."
 - 2. Disposal of demolished materials: refer to Division 01 Section "Construction Waste Management."
- 1.2 **DEFINITIONS**
 - A. Remove: Detach items from existing construction and legally dispose of them off-site, at a permitted Subtitle D landfill in accordance with Division 31 Section "Soil, Fill, Backfill, CU Structural Soil & Construction & Demo Debris Removal," unless indicated to be removed and salvaged or removed and reinstalled.
 - B. Remove and Salvage: Detach items from existing construction, where indicated, and deliver them to Owner ready for reuse.
 - C. Remove and Reinstall: Detach items from existing construction, prepare them for reuse, and reinstall them where indicated.
 - D. Existing to Remain: Existing items of construction that are not to be removed and that are not otherwise indicated to be removed, removed and salvaged, or removed and reinstalled.

1.3 MATERIALS OWNERSHIP

- A. Historic items indicated and historic items, relics, and similar objects including, but not limited to, cornerstones and their contents, commemorative plaques and tablets, antiques, and other items of interest or value to Owner that may be encountered during selective demolition remain Owner's property. Carefully remove and salvage each item or object in a manner to prevent damage and deliver promptly to Owner.
 - 1. Coordinate with Owner who will establish special procedures for removal and salvage.

1.4 SUBMITTALS

- A. Schedule of Selective Demolition Activities: Indicate the following:
 - 1. For purposes of Owner's information only, sequence of selective demolition and removal work, with starting and ending dates for each activity. Ensure Owner's on-site operations are uninterrupted.
 - 2. Interruption of utility services. Indicate how long utility services will be interrupted.
 - 3. Coordination for shutoff, capping, and continuation of utility services.
 - 4. Use of elevator and stairs if acceptable to the Owner.
 - 5. Locations of proposed dust- and noise-control temporary partitions and means of egress.
 - 6. Means of protection for items to remain and items in path of waste removal from building.
- B. Inventory: After selective demolition is complete, submit a list of items that have been removed and salvaged.
- C. Predemolition Photographs or Videotapes: Show existing conditions of adjoining construction and site improvements, including finish surfaces, that might be misconstrued as damage caused by selective demolition operations.
- D. Landfill Records: Comply with submittal requirements in Division 1 Section "Construction Waste Management."
- E. Statement of Refrigerant Recovery: Signed by refrigerant recovery technician responsible for recovering refrigerant, stating that all

refrigerant that was present was recovered and that recovery was performed according to EPA regulations. Include name and address of technician and date refrigerant was recovered.

1.5 QUALITY ASSURANCE

- A. Demolition Firm Qualifications: An experienced firm that has specialized in demolition work similar in material and extent to that indicated for this Project.
- B. Regulatory Requirements: Comply with governing EPA notification regulations before beginning selective demolition. Comply with hauling and disposal regulations of authorities having jurisdiction.
- C. Standards: Comply with ANSI A10.6 and NFPA 241.
- D. Predemolition Conference: Conduct conference at Project site to comply with requirements in Division 01 Section "Project Management and Coordination." Review methods and procedures related to selective demolition including, but not limited to, the following:
 - 1. Inspect and discuss condition of construction to be selectively demolished.
 - 2. Review and finalize selective demolition schedule and verify availability of materials, demolition personnel, equipment, and facilities needed to make progress and avoid delays.
 - 3. Review requirements of work performed by other trades that rely on substrates exposed by selective demolition operations.
 - 4. Review areas where existing construction is to remain and requires protection.

1.6 **PROJECT CONDITIONS**

- A. Conditions existing at time of inspection for bidding purpose will be maintained by Owner as far as practical.
 - 1. Before selective demolition, Owner will remove the items as discussed at pre-demolition conference.
- B. Notify Landscape Architect of discrepancies between existing conditions and Drawings before proceeding with selective demolition.

- C. Hazardous Materials: Start operation under this section only after hazardous materials have been removed in accordance with related sections.
 - 1. If materials suspected of containing hazardous materials are encountered, do not disturb; immediately notify Village engineer, Landscape Architect, the Managing Environmental Consultant, and the Owner.
- D. Storage or sale of removed items or materials on-site is not permitted.
- E. Utility Service: Maintain existing utilities required to remain in service and protect them against damage during selective demolition operations. Maintain fire-protection facilities in service during selective demolition operations.
- 1.7 EXISTING SPECIAL SYSTEMS
 - A. Inspect the facility for the presence of special systems that must be maintained operational during demolition in the presence of the Owner. Such systems include security systems, access control systems, fire and smoke detection and alarm systems and communication systems.
 - B. Develop a strategy with the Owner to maintain such systems operational during alterations including temporary re-working, unavoidable down time, acceptable discontinuing of service intervals and contingencies for notification of involved agencies.
 - C. Instruct every Subcontractor as to the procedures to be followed and supervise the process to ensure implementation.
 - D. Restore such systems and extend them into the altered area.
 - E. Include all services and materials in the Contract Sum.

PRODUCTS (Not Used) EXECUTION

- 1.8 **EXAMINATION**
 - A. Verify that utilities have been disconnected and capped.

- B. Survey existing conditions and correlate with requirements indicated to determine extent of selective demolition required.
- C. Inventory and record the condition of items to be removed and reinstalled and items to be removed and salvaged.
- D. When unanticipated mechanical, electrical, or structural elements that conflict with intended function or design are encountered, investigate and measure the nature and extent of conflict. Promptly submit a written report to Village Engineer / Owner.
- E. Engage a professional engineer to survey condition of removed elements to determine whether removing any element might result in structural deficiency or unplanned collapse of any portion of structure or adjacent structures during selective demolition operations.
- F. Survey of Existing Conditions: Record existing conditions by use of preconstruction photographs and preconstruction videotapes.
 - 1. Before selective demolition or removal of existing elements that will be reproduced or duplicated in final Work, make permanent record of measurements, materials, and construction details required to make exact reproduction.
- G. Perform surveys as the Work progresses to detect hazards resulting from selective demolition activities.
- 1.9 UTILITY SERVICES AND MECHANICAL/ELECTRICAL SYSTEMS
 - A. Existing Services/Systems: Maintain services/systems indicated to remain and protect them against damage during selective demolition operations.
 - B. Service/System Requirements: Locate, identify, disconnect, and seal or cap off indicated utility services and mechanical/electrical systems serving areas to be selectively demolished.
 - 1. Arrange to shut off indicated utilities with utility companies.
 - 2. If services/systems are required to be removed, relocated, or abandoned, before proceeding with selective demolition provide temporary services/systems that bypass area of selective demolition and that maintain continuity of services/systems to other parts of building.

3. Cut off pipe or conduit in walls or partitions to be removed. Cap, valve, or plug and seal remaining portion of pipe or conduit after bypassing.

1.10 **PREPARATION**

- A. Site Access and Temporary Controls: Conduct selective demolition and debris-removal operations to ensure minimum interference with roads, streets, walks, walkways, and other adjacent occupied and used facilities.
- B. Temporary Facilities: Provide temporary barricades and other protection required to prevent injury to people and damage to adjacent buildings and facilities to remain.
 - 1. Provide protection to ensure safe passage of people around selective demolition area.
 - 2. Provide temporary weather protection, during interval between selective demolition of existing construction on exterior surfaces and new construction, to prevent water leakage and damage to structure and interior areas.
 - 3. Protect walls, ceilings, floors, and other existing finish work that are to remain or that are exposed during selective demolition operations.
 - 4. Cover and protect furniture, furnishings, and equipment that have not been removed.
 - Comply with requirements for temporary enclosures, dust control, heating, and cooling specified in Division 1 Section "Temporary Facilities and Controls."
- C. Temporary Shoring: Provide and maintain shoring, bracing, and structural supports as required to preserve stability and prevent movement, settlement, or collapse of construction and finishes to remain, and to prevent unexpected or uncontrolled movement or collapse of construction being demolished. Strengthen or add new supports when required during progress of selective demolition.

1.11 SELECTIVE DEMOLITION, GENERAL

A. General: Demolish and remove existing construction only to the extent required by new construction and as indicated. Use methods required to complete the Work within limitations of governing regulations and as follows:

- 1. Proceed with selective demolition systematically, from higher to lower level. Complete selective demolition operations above each floor or tier before disturbing supporting members on the next lower level.
- 2. Neatly cut openings and holes plumb, square, and true to dimensions required. Use cutting methods least likely to damage construction to remain or adjoining construction. Use hand tools or small power tools designed for sawing or grinding, not hammering and chopping, to minimize disturbance of adjacent surfaces. Temporarily cover openings to remain.
- 3. Cut or drill from the exposed or finished side into concealed surfaces to avoid marring existing finished surfaces.
- 4. Do not use cutting torches until work area is cleared of flammable materials. At concealed spaces, such as duct and pipe interiors, verify condition and contents of hidden space before starting flame-cutting operations. Maintain fire watch and portable fire-suppression devices during flame-cutting operations.
- 5. Maintain adequate ventilation when using cutting torches.
- 6. Remove decayed, vermin-infested, or otherwise dangerous or unsuitable materials and promptly dispose of off-site at a permitted Subtitle D landfill facility.
- 7. Remove structural framing members and lower to ground by method suitable to avoid free fall and to prevent ground impact or dust generation.
- 8. Locate selective demolition equipment and remove debris and materials so as not to impose excessive loads on supporting celling, walls, floors, or framing.
- 9. Dispose of demolished items and materials at a permitted Subtitle D landfill promptly.
- B. Removed and Salvaged Items:
 - 1. Clean salvaged items.
 - 2. Pack or crate items after cleaning. Identify contents of containers.
 - 3. Store items in a secure area until delivery to Owner.
 - 4. Transport items to Owner's storage area designated by Owner.
 - 5. Protect items from damage during transport and storage.
- C. Removed and Reinstalled Items:
 - 1. Clean and repair items to functional condition adequate for intended reuse. Paint equipment to match new equipment.

- 2. Pack or crate items after cleaning and repairing. Identify contents of containers.
- 3. Protect items from damage during transport and storage.
- 4. Reinstall items in locations indicated. Comply with installation requirements for new materials and equipment. Provide connections, supports, and miscellaneous materials necessary to make item functional for use indicated.
- D. Existing Items to Remain: Protect construction indicated to remain against damage and soiling during selective demolition. Items may be removed to a suitable, protected storage location during selective demolition and cleaned and reinstalled in their original locations after selective demolition operations are complete.

1.12 SELECTIVE DEMOLITION PROCEDURES FOR SPECIFIC MATERIALS

- A. Concrete: Demolish in sections. Cut concrete full depth at junctures with construction to remain and at regular intervals, using power-driven saw, then remove concrete between saw cuts.
- B. Concrete Slabs-on-Grade: Saw-cut perimeter of area to be demolished, then break up and remove.
- C. Unit pavers: Remove unit pavers, setting bed and subgrade.
- D. Topsoil and existing plantings (trees not included): Remove topsoil, plantings as indicated on drawings.
- 1.13 MANAGEMENT OF DEMOLISHED MATERIALS
 - A. Separate recyclable demolished materials from other demolished materials to the maximum extent possible. Separate recyclable materials by type.
 - 1. Provide containers or other storage method for controlling recyclable materials until they are removed from Project site.
 - 2. Stockpile processed material on-site without intermixing with other materials. Place, grade, and shape stockpiles to drain surface water. Cover to prevent windblown dust.
 - 3. Stockpile materials away from demolition area. Do not store within drip line of remaining trees.
 - 4. Store components off the ground and protect from the weather.

- 5. Transport materials off Owner's property and legally dispose of all materials at a Permitted Subtitle D landfill in accordance with Division 31 Section "Soil, Fill, Backfill, CU Structural Soil & Construction & Demo Debris Removal" as applicable. Comply with the requirements of Division 31 Section "Soil, Fill, Backfill, CU Structural Soil & Construction & Demo Debris Removal" as applicable.
- B. Remove from the site and legally dispose of non-recyclable debris, rubbish, and other materials resulting from demolition operations at a Subtitle D landfill in accordance with Division 31 Section "Soil, Fill, Backfill, CU Structural Soil & Construction & Demo Debris Removal" as applicable.
- C. Comply with requirements specified in Division 1 Section "Construction Waste Management."
- D. Burning: Do not burn demolished materials.
- E. Disposal: Transport non-recyclable demolished materials off Owner's property and legally disposes of them at a Subtitle D Landfill in accordance with Division 31 Section "Soil, Fill, Backfill, CU Structural Soil & Construction & Demo Debris Removal" as applicable.
- 1.14 CLEANING
 - A. Clean adjacent structures and improvements of dust, dirt, and debris caused by selective demolition operations. Return adjacent areas to condition existing before selective demolition operations began.

Method of Measurement

REMOVAL PLAZA CONCRETE, PAVERS & SUBGRAGE TO 12" DEPTH and SELECTIVE DEMOLITION OF LAWN, PLANTING (TREES NOT INCLUDED) AND SOIL TO 12" DEPTH will be paid for at the contract price and the area computed in square foot, which price shall include removal of concrete, pavers & subgrade to 12" depth, and selective demolition lawn, planting (trees not included) and soil to 12" depth, as well as protecting existing basement-garage waterproofing when removing overburden as described.

Basis of Payment

This work will be paid at the contract unit price per square foot for REMOVE PLAZA PAVING AND SUBGRAGE TO 12" DEPTH and REMOVE EXISTING LAWN, PLANTING AND SOIL TO 12" DEPTH AT PLAZA AREA and which price shall be payment for completing the work as specified.
