

**RENEWAL OF A CROSSING GUARD SERVICES AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND ANDY FRAIN SERVICES, INC.**

**THIS RENEWAL OF THE CROSSING GUARD SERVICES AGREEMENT** (hereinafter “Renewal”) between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the “Village”), and Andy Frain Services, Inc., an Illinois corporation (hereinafter the “Contractor”) is entered into as of the effective date set forth below (collectively referred to as the “Parties”).

**RECITALS**

**WHEREAS**, the Parties previously entered into a Crossing Guard Services Agreement for School Crossings Related to Oak Park Elementary School District No. 97 (“Agreement”); and

**WHEREAS**, the Parties seek to renew the Agreement as set forth herein.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
2. **RENEWAL OF AGREEMENT.** The Agreement between the Parties is hereby renewed pursuant to the terms of the Agreement for the period of July 1, 2019 at 12:01 a.m. through June 30, 2020 at 11:59 p.m. pursuant to Section 4.1 of the Agreement.
3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.
4. **EFFECTIVE DATE.** This Renewal shall be effective on the date of its execution by the Village Manager of the Village of Oak Park.
