RESOLUTION

A RESOLUTION APPROVING THE FINAL PROGRAM YEAR 2019 ACTION PLAN FOR FEDERAL COMMUNITY DEVELOPMENT BLOCK GRANT AND EMERGENCY SOLUTIONS GRANT FUNDS AND SUBMITTING THE PLAN TO <u>THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT</u>

WHEREAS, the Village of Oak Park is an Entitlement Community under the Housing and Community Development Act of 1974, as amended, and is therefore eligible to receive Community Development Block Grant ("CDBG") and Emergency Solutions Grant ("ESG") funds from the U.S. Department of Housing and Urban Development ("HUD") for each program year; and

WHEREAS, in order to receive these grant funds each year, the Village must submit an Action Plan to HUD forty-five (45) days before the beginning of the program year start, with the Program Year 2019 final Action Plan being due to HUD by August 15, 2019; and

WHEREAS, the Draft Program Year 2019 Action Plan contained Community Development Citizens Advisory Committee funding recommendations for proposed Program Year 2019 CDBG and ESG activities for local non-profit agencies, and this draft Plan was approved at the June 17, 2019 Village Board meeting; and

WHEREAS, as required by HUD Consolidated Plan regulations, and after approval at the June 17, 2019 Village Board meeting, the Village initiated a citizen participation and review process during the Program Year 2019 Draft Action Plan comment period, which ran from June 20 to July 19, 2019, with no public comments being received.

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

Section 1. Recitals Incorporated. The above recitals are incorporated herein as though fully set forth.

Section 2. Approval/Submittal. The Program Year 2019 Action Plan is approved and the Village Manager is authorized to submit the document and any subsequent amendments to HUD.
