## ORDINANCE

## AN ORDINANCE AMENDING ARTICLE 8 ("USES"), SECTION 8.3 ("USE RESTRICTIONS"), TABLE 8-1 ("USE MATRIX") OF THE OAK PARK ZONING ORDINANCE ESTABLISHING AN EDUCATIONAL FACILITY – PRIMARY OR SECONDARY AS A SPECIAL USE IN THE RR-ROOSEVELT ROAD ZONING DISTRICT

WHEREAS, on August 1, 2019 the Village of Oak Park Plan Commission ("Plan Commission") held a public hearing on the application of the Petitioner, Talley Hann, Jessica Flannery and Chloe Cunningham for Oak Park Friends School. ("Applicant"), for a text amendment to Article 8 ("Uses"), Section 8.3 ("Use Restrictions"), Table 8-1 ("Use Matrix") of the Oak Park Zoning Ordinance to add Educational Facility – Primary or Secondary as a special use in the RR - Roosevelt Road Zoning District; and

**WHEREAS**, notice of the public hearing was published in the *Wednesday Journal* on July 17, 2019; and

WHEREAS, the Plan Commission recommended that the text amendment reflected in this Ordinance be granted by a vote of six (6) in favor and zero (0) against upon the close of the public hearing held on August 1, 2019, as reflected in the minutes of the public hearing, incorporated herein by reference as though fully set forth; and

WHEREAS, the Plan Commission adopted its Findings of Fact and Recommendation on August 1, 2019, which is adopted by the President and Board of Trustees of the Village and incorporated herein as though fully set forth; and

WHEREAS, the President and Board of Trustees of the Village have considered the Plan Commission's Findings of Fact and Recommendation and have determined that it is appropriate to grant the text amendment as provided in this Ordinance.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

- **Section 1. Recitals Incorporated.** The above recitals are incorporated herein by reference as though fully set forth.
- **Section 2. Zoning Ordinance Amended.** Article 8 ("Uses"), Section 8.3 ("Use Restrictions"), Table 8-1: ("Use Matrix") of the Oak Park Zoning Ordinance is amended to add the underlined language to read as follows:
