

**A SECOND AMENDMENT TO A CONTRACT BETWEEN  
THE VILLAGE OF OAK PARK AND NORVILLA, LLC, FOR PROJECT 18-14,  
BRIDGE REHABILITATION PROJECT,  
TO CHANGE THE NOT TO EXCEED AMOUNT FROM \$351,556 TO \$444,002**

**THIS SECOND AMENDMENT (“SECOND AMENDMENT”) TO THE CONTRACT DATED** September 6, 2018 between the Village of Oak Park, an Illinois home rule municipal corporation, and Norvilla, LLC, an Illinois limited liability company, is entered into this \_\_\_\_ day of September, 2019 (collectively referred to as the “Parties”).

**RECITALS**

**WHEREAS**, the Parties entered into a Contract dated September 6, 2018 (“Contract”) and Amendment dated October 29, 2018; and

**WHEREAS**, the Parties seek to amend the Contract pursuant to this Second Amendment to reflect the additional amount of \$92,446 to the Contract amount for a new total amount of \$444,002.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO CONTRACT.** The Contract is amended by adding the underlined language and deleting the overstricken language as follows:

THIS CONTRACT is entered into this 6<sup>th</sup> day of September, 2018 by and between the Village of Oak Park, 123 Madison St., Oak Park, IL 60302 acting by and through its President and Board of Trustees and Norvilla, LLC, an Illinois limited liability corporation with offices at 2701 S. 13th Avenue, Broadview, Illinois 60155, its executors, administrators, successors or assigns (hereinafter “Contractor”) in an amount not to exceed ~~\$351,556~~ \$444,002.

3. **OTHER PROVISIONS OF THE CONTRACT TO REMAIN IN EFFECT.** All other terms and conditions of the Contract shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Second Amendment to the Contract shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
