2018 Completed Initiatives

Narrative

The workplan submitted by the BOH in 2017 was robust. The projects identified were primarily a response to the data and needs identified in the Comprehensive Community Needs Assessment and subsequent comprehensive Community Plan. This assessment and plan were focused on both short term and long term (5 year) goals. All of those goals are in an ongoing process.

The BOH has also experienced a significant turnover in membership due to employment and family responsibilities. Two (2) members resigned in late 2017 as a result of changes in work responsibilities, one (1) due to work relocation (early 2018) and one (1) member (early 2018) due to increased family responsibilities. This resulted in the onboarding of 4 new members and contributed to the lack of progress on some of the projects.

In 2018 the BOH received 2 projects from the Village Board that were not on the 2018 workplan. The review of the Village Code related to "Animals Prohibited in Public Buildings as relates to Food Establishments" required 3 meetings to discuss and develop documents for submission to the Village Board. This included extensive public comment at 2 of the 3 meetings as well as presentations by the business owner who made the original request for ordinance change to the Village Board. The final 32-page document provided the Village Board with data on which a decision was made in support of ordinance change. The second project "Limitation on Animals per Household" as it relates to multi-family properties is currently being addressed.
