
Village of Oak Park Public Works Department Replacement of Lombard Side Door at Village Hall **INVITATION TO BID**

GENERAL SCOPE OF WORK

The Village of Oak Park Village Hall, located at 123 Madison St., Oak Park, IL 60302, has an exterior ADA accessible automatic door at the bottom of the ADA ramp on the west side (Lombard St.) of the building that is in need of replacement (including the frame around the door). The existing door has an ADA paddle on the outside that operates the door and a push button opener on the inside.

The Village is seeking bids from qualified door companies to replace the door, framework, hardware (door sweep, hinges), signage, and all associated electrical components (door strike, card reader, intercom [Alt.#1]).
