

Vendor agrees to extend all terms and conditions, specifications, and pricing or discounts specified in this contract to all governmental units and qualified not-for-profit agencies.

The supplies or services in this contract shall be distributed or rendered directly to each governmental unit or qualified not-for-profit agency. Vendor shall bill each governmental unit or qualified not-for-profit agency separately for its actual share of the costs of the supplies or services purchased. The credit or liability of each governmental unit or qualified not-for-profit agency shall remain separate and distinct. Disputes between vendors and governmental units or qualified not-for-profit agencies shall be resolved between the affected parties. All terms and conditions in this Contract apply with full force and effect to all purchase orders.
