A RESOLUTION APPROVING THE RENEWAL OF AN INDEPENDENT CONTRACTOR AGREEMENT WITH G. A. PAVING CONSTRUCTION, INC. IN AN AMOUNT NOT TO EXCEED \$175,000 FOR SNOW PLOWING AND SALTING OF VILLAGE LEASED/OWNED PARKING LOTS AND BACK-UP SNOW REMOVAL FOR PUBLIC STREETS FOR THE 2019 SNOW SEASON AND AUTHORIZING ITS EXECUTION

BE IT RESOLVED by the President and Board of Trustees of the Village of Oak Park, Cook County, State of Illinois ("Village"), in the exercise of their home rule powers, that the Renewal of the Independent Contractor Agreement ("Renewal") with G. A. Paving Construction, Inc. for a one (1) year period is approved in an amount not to exceed \$175,000 for snow plowing and salting of Village leased/owned parking lots and back-up snow removal for public streets for the 2019 snow season and the Village Manager is authorized to execute the Renewal in substantially the form attached.

THIS RESOLUTION shall be in full force and effect from and after its adoption and approval as provided by law.

RENEWAL OF AN INDEPENDENT CONTRACTOR AGREEMENT BETWEEN
THE VILLAGE OF OAK PARK AND G. A. PAVING CONSTRUCTION, INC. IN AN
AMOUNT NOT TO EXCEED \$175,000 FOR SNOW PLOWING AND SALTING OF
VILLAGE LEASED/OWNED PARKING LOTS AND BACK-UP SNOW REMOVAL
FOR PUBLIC STREETS FOR THE 2019 SNOW SEASON

THIS RENEWAL OF THE INDEPENDENT CONTRACTOR AGREEMENT (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and G. A. Paving Construction, Inc. an Illinois corporation (hereinafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

RECITALS

WHEREAS, the Parties previously entered into an Independent Contractor Agreement dated December 11, 2017 ("Agreement"); and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement in an amount not to exceed \$175,000 for snow plowing and salting of Village leased/owned parking lots and back-up snow removal for public streets for 2019 snow season.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. <u>RECITALS INCORPORATED.</u> The above recitals are incorporated herein as though fully set forth.
- 2. <u>RENEWAL OF AGREEMENT.</u> The Agreement between the Parties is hereby renewed pursuant to the terms of Section 4 of the Agreement for an additional one (1) year term through December 31, 2019.
- 3. OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT. All other terms and conditions of the Agreement shall remain in full force and effect.
- 4. <u>EFFECTIVE DATE.</u> This Renewal shall be effective on the last date of its execution by one of the parties as reflected below.
