

**A SECOND AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND MEADE, INC. FOR  
EMERGENCY STREET LIGHTING AND TRAFFIC CONTROL REPAIRS  
FOR A NEW NOT TO EXCEED AMOUNT OF \$49,685.22**

**THIS SECOND AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT** (hereinafter referred to as "Second Amendment") between the Village of Oak Park, an Illinois home rule municipal corporation, and Meade, Inc., an Illinois corporation, is entered into this \_\_\_\_ day of January 2020 (collectively referred to as the "Parties").

**RECITALS**

**WHEREAS**, the Parties entered into an Independent Contractor Agreement dated March 11, 2019 ("Agreement"); and

**WHEREAS**, the Parties seek to amend Section 2 of the Agreement pursuant to this Second Amendment to reflect a new not to exceed amount of \$49,685.22

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

Contractor shall perform the Work for the Project in accordance with its Proposal for a price not to exceed ~~\$39,000.00~~ \$49,685.22 ("Contract Price"). Contractor shall complete the Work in accordance with any applicable manufacturers' warranties and in accordance with its Proposal, the Village's Request for Proposals, and this Contract, all of which, together shall constitute the "Contract Documents."

3. **OTHER PROVISIONS OF THE CONTRACT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
