

## A RESOLUTION APPROVING A RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT WITH SECURITAS SECURITY SERVICES USA, INC. IN AN AMOUNT NOT TO EXCEED \$490,000 FOR SECURITY SERVICES AT VILLAGE PARKING STRUCTURES AND NOT TO EXCEED \$30,000 FOR SECURITY SERVICES AT VILLAGE HALL FOR FISCAL YEAR 2018 AND AUTHORIZING ITS EXECUTION

BE IT RESOLVED by the President and Board of Trustees of the Village of Oak Park, Cook County, State of Illinois ("Village"), in the exercise of their home rule powers, that the Renewal of the Professional Services Agreement ("Renewal") with Securitas Security Services USA, Inc. for fiscal year 2018 is approved in an amount not to exceed \$490,000 for security services at Village parking structures and not to exceed for security services at Village Hall and the Village Manager is authorized to execute the Renewal in substantially the form attached.

RENEWAL OF A PROFESSIONAL SERVICES AGREEMENT BETWEEN
THE VILLAGE OF OAK PARK AND SECURITAS SECURITY SERVICES USA, INC.
IN AN AMOUNT NOT TO EXCEED \$490,000 FOR SECURITY SERVICES
AT VILLAGE PARKING STRUCTURES AND NOT TO EXCEED \$30,000 FOR
SECURITY SERVICES AT VILLAGE HALL FOR FISCAL YEAR 2018

THIS RENEWAL OF THE PROFESSIONAL SERVICES AGREEMENT DATED OCTOBER 20, 2016 (hereinafter "Renewal") between the Village of Oak Park, an Illinois home rule municipal corporation (hereinafter the "Village"), and Securitas Security Services USA, Inc. a Delaware corporation authorized to conduct business in the State of Illinois (hereinafter the "Contractor") is entered into as of the effective date set forth below (collectively referred to as the "Parties").

## RECITALS

WHEREAS, the Parties previously entered into a Professional Services Agreement dated October 20, 2016 ("Agreement"); and

WHEREAS, the Parties seek to renew the Agreement pursuant to the terms of the Agreement and this Renewal in an amount not to exceed \$490,000 for security services at Village parking structures and not to exceed \$30,000 for security services at Village Hall for fiscal year 2018.

NOW, THEREFORE, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. <u>RECITALS INCORPORATED.</u> The above recitals are incorporated herein as though fully set forth.
- 2. <u>RENEWAL OF AGREEMENT AND TERM.</u> The Agreement between the Parties Is hereby renewed pursuant to the terms of Section 4.1 of the Agreement and this Renewal for an additional one (1) year term beginning at 12:01 a.m. on January 1, 2018 and ending at 11:59 p.m. on December 31, 2018.
- 3. <u>LIVING WAGE REQUIREMENTS.</u> The requirements of Section 2-6-20 of the Oak Park Village Code regarding a living wage for employees of Village contractors and/or subcontractors shall be applicable to this Renewal. Contractor shall comply with the provisions of Section 2-6-20 during the renewal term set forth in Section 2 above pursuant to the not to exceed amounts set forth herein.
- 4. <u>CONTRACTOR'S AUTHORIZED REPRESENTATIVE AND NOTICES.</u> Contractor's authorized representative for purposes of Section 2.5 of the Agreement shall be Keith Toms. Notices to Contractor for purposes of Section 18.1 of the Agreement shall be provided as follows:

- 5. <u>OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.</u> All other terms and conditions of the Agreement shall remain in full force and effect.
- 6. <u>EFFECTIVE DATE.</u> This Renewal shall be effective on the last date of its execution by one of the parties as reflected below.
