

**ORDINANCE**

**AN ORDINANCE AMENDING SECTION 15-3-18(F) OF THE OAK PARK VILLAGE CODE  
REGARDING PARKING RATES FOR THE VILLAGE’S AVENUE GARAGE**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Village Code Amended.** Chapter 15 (“Motor Vehicles and Traffic”), Article 3 (“Parking Meters, Parking Permits and Municipal Attendant Parking Lots”), Section 15-3-18 (“Parking Rates; Parking Meters, Pay by Space Machines, Village Operated Parking Structures, Permit, Extended Pass, Valet and Daytime On Street Permit Parking”) of the Oak Park Village Code is hereby amended to delete the overstricken language and add the underlined language to read as follows:

**5-3-18: PARKING RATES; PARKING METERS, PAY BY SPACE MACHINES, VILLAGE OPERATED PARKING STRUCTURES, PERMIT, EXTENDED PASS, VALET AND DAYTIME ON STREET PERMIT PARKING:**

F. Village Operated Multilevel Parking Structures Parking Rates (Except For The Oak Park River Forest High School Parking Structure ~~And the Avenue Garage~~): The fee for parking in Village operated multilevel parking structures other than by meter or permit (except for the Oak Park River Forest High School parking structure ~~and the Avenue Garage~~) on Monday through Saturday shall be as follows:

<u>Duration</u>	<u>Parking Fee</u>
0 to 1.5 hour	Free
1.5 to 2.5 hours	\$ 2.00
2.5 to 3.5 hours	3.00
3 to 4.5 hours	4.00
4.5 to 5.5	4.72

5.5 to 6.5 hours	5.67
6.5 to 10 hours	10.38
10 to 24 hours	15.09

The fee for parking in the Avenue Garage on Monday through Saturday shall be as follows:

<u>Duration</u>	<u>Parking Fee</u>
<del>0 to 1 hour</del>	<del>Free</del>
<del>1 to 2.5 hours</del>	<del>\$ 2.00</del>
2.5 to 3 hours	3.00
<del>3 to 3.5 hours</del>	<del>3.77</del>
<del>3.5 to 4 hours</del>	<del>4.72</del>
4 to 10 hours	10.38
10 to 24 hours	15.09

Except parking in Village operated multilevel parking structures (except for the Oak Park River Forest High School parking structure) shall be free of charge on the following dates:

July 4

The day after Thanksgiving Day

Every Saturday that falls after Thanksgiving Day and prior to December 25

**Section 2. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 3. Effective Date.** This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
