#### Case in Local Nursing Home

Oak Park Public Health Director Mike Charley reported that a resident of a local retirement and assisted living facility had tested positive for the COVID-19 coronavirus. The resident is currently being cared for in a local hospital. The Oak Park Oasis, 625 North Harlem Avenue, Oak Park, Illinois, operated by Oak Park Oasis LLC ("Oasis"), has been ordered to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees. In addition strict measures preventing the acceptance of any new residents or rehabilitation patients are in place. Other measures include the prohibition of any visitors and canceling events or gatherings within the facility.

Failure to comply with the public health order is a Class A misdemeanor under state law, which carries a maximum penalty of a year in jail and a \$2,500 fine. In addition, the facility could lose its license and face civil liability.

#### Social Service Task Force

On Monday, March 30, 2020, the Social Services Task Force meeting chaired by the Oak Park Township was held. The Village's liaison, Development Customer Services Director Tammie Grossman shared that the Township gave an overview of their current volunteer recruitment for delivering meals and providing groceries to the seniors. Additionally, the Mental Health Board gave an update on the mental services guide that they prepared for individuals in need of services. The actual document is updated weekly and therefore it is recommended that the link be shared, not the actual document. Other agencies gave updates on their programs including Housing Forward which has temporarily housed all homeless individuals that they are currently working with in various hotels and they are working with the Township for meal delivery and are working to assign case managers. Beyond Hunger is no longer accepting new volunteers and implemented curbside pick-up of food to avoid contact.

### Council of Governments (COG)

The Oak Park COG held a GoToMeetings call today combined with the River Forest and Forest Park COGs. The COG is the chief elected and chief appointed official from each taxing body and has allowed for important discussion around shared actions and shared information.

### Governor's Order

During his daily press briefing yesterday, March 31<sup>st</sup> Governor JB Pritzker announced that on Wednesday, April 1, he will be extending the disaster proclamation, the suspension of on-site learning at schools and the 'Stay At Home' Order through April 30. The order has not yet been published. It is staff's intention to maintain the current changes that have temporarily eased many parking restriction, subject to approval by the Village Board of an extension of the March 13 Village's Declaration of an Emergency Affecting Public Health which will be presented at the next regular meeting of the Village Board on April 6<sup>th</sup>. That meeting will be conducted remotely with live audio available and optional video. The meeting will be streamed live and archived online for on-demand viewing at [www.oak-park.us/boardtv](http://www.oak-park.us/boardtv) as well as cablecast on VOP-TV, which is available to Comcast subscribers on channel 6 and ATT Uverse subscribers on channel 99. Remote Meetings of the Oak Park Village Board of Trustees is authorized pursuant to Section 6 of Governor J.B. Pritzker's Executive Order 2020-07. The meeting agenda and related materials will be posted by the end of the day on Thursday, April 2.

Oak Park Public Health Director Mike Charley reported today the first death of an Oak Park resident, a man in his 60s, believed to be related to the COVID-19 coronavirus. The man had earlier tested positive for the virus, but the final cause of death will be determined by the Cook County Medical Examiner. The expressed sincere condolences to the man's family for their loss.

The agenda and materials are available on the Village website. In compliance with the Executive Order of the Governor the agenda is limited to matters necessary during the Village's emergency response to the COVID-19 outbreak.

Alternatively, if email is not an option, individuals can drop written comments off at the Oak Park Payment Drop box located across from the entrance to Village Hall, 123 Madison Street, to be received no later than 5 p.m. the day of the meeting.

### Supplemental Public Health Order for Grocery Stores

A Supplemental Order was issued by Public Health Director Charley for stores that sell groceries was issued and will be effective April 4 at noon to improve the compliance with social distancing for shoppers and employees. Example of new requirement are limits on the total customers allowed in a store at any one time (which varies by store related to their size) and more controls on the flow of shoppers through stores by use of one-way aisles to reduce the frequency of customers crossing paths. Additionally, stores must place shield guards in front of cashiers and/or baggers that may not have the ability to meet the social distancing requirements when serving customers. Stores received information on April 3 from Public Health Staff along with two laminated Customer Occupancy signs that are required to be posted in a location that is easily visible from the exterior of the store. Also, establishments were advised on how to safely structure lines of customers as to not impede vehicle or pedestrian traffic. Stores managers were receptive to the requirements. ## Real Estate Transfer Stamps

The Finance Department has been selling real estate transfer stamps “by appointment only” since March 16. During this short time, there have been approximately 120 transactions. The process for purchasing transfer stamps is being done primarily electronically followed by final meter reads and an appointment for the final issuance of stamps which is completed with the customer limited to the vestibule at Village Hall with social distancing practices being maintained.

## FEMA Public Assistance

On March 24, the Village submitted a Request for Public Assistance (PA) to the Federal Emergency Management Agency (FEMA) which started the process of securing grant funding for COVID-19 related expenses. In addition, on March 30, staff mailed to the Illinois Emergency Management Agency (IEMA) completed and signed copies of the PA Grant Agreement, PA Risk Assessment, and PA Federal Funding Accountability and Transparency (FFATA) certification forms. The next steps in the process will involve an Exploratory Call, Recovery Scoping Meeting, and the preparation of Project Worksheets to request reimbursement.

It is noted that with the multiple funding streams currently being allocated at the Federal and State levels, the Village does not yet have clarity on what Public Assistance funds will cover and what other assistance will be made available at the municipal level and how to apply for those funds. Once IEMA/FEMA provides further guidance an update will be provided.

## Website Traffic

Since the Village Board's initial emergency declaration on March 13, 2020, website page views have grown substantially. In a typical full month, the Village website will get 110,000 to 120,000 page views. But the Village website had 167,000-plus page views just since March 14.

The COVID-19 page is by far the most visited page since March 14 with 50,000-plus page views. To put that in perspective, in a normal month, our most visited page normally gets about 7,000 to 8,000 views, usually related to parking. The other most visited pages since March 14 are news stories related to COVID-19.

Communications staff is posting updated positive tests each day, sharing the information via email and on our social media sites. We also are sharing information of value to citizens, relying primarily on official sources like the Centers for Disease Control and Prevention and the Illinois Department of Public health, which publishes information from the Governor as well. In addition, all bulletins, orders and guidelines issued by Public Health Director Michael Charley are disseminated to the community and posted on the website [www.oak-park.us/covid19](http://www.oak-park.us/covid19).

The approach has been to use official information from other sources via links, rather than copying and branding the same information as being local. Since the information is changing rapidly and often unexpectedly, this approach has been essential to help ensure any information on our website is up to date and eliminates out of date information from being inadvertently accessed on the Village site if the original source has made updates.

### Staffing Updates

The Public Works Department announced the promotion of Rob Sproule to Assistant Public Works Director. This new position was established in the FY20 budget and the competitive recruitment for this position was initiated and completed prior to the Village Board's declaration of an Emergency affecting Public Health, with the announcement made to staff in mid-March. Rob has been with the Village since May 2014 serving as the Forestry Superintendent. He has a Bachelor of Arts Degree from Fordham University and a Master of Forestry Degree from the University of Maine as well as several notable accomplishments including being a Board Certified Master Arborist. Rob has taken a lead role in many activities for the Public Works Department since coming on board and continues to show his strong leadership skills during the COVID-19 event.

### Supplemental Order for Public Sports Courts and certain other prohibited activities

Supplemental Order for Public Sports Courts and certain other prohibited activities was extended today through May 5, 2020. The extension affirms that gatherings for sports in public areas that is at public parks or outdoor recreation areas are prohibited in order to protect the public from the spread of COVID-19 disease because such activities could entail or promote non-compliance with the social distancing requirements set forth in Governor Pritzker's Order.

This was done in order to appeal to the public and essential businesses in the community regarding the important responsibility we all have to ensure our community is working together to limit community spread of COVID-19. The Public Health Department is concerned that without full cooperation we may not achieve the necessary impact to slow the spread and therefore, the guidance and order have been issued to assist as we move towards more robust conversations when violations are encountered.

## **Senior Housing Case**

Oak Park Public Health Director Mike Charley reported that a resident of a local retirement and assisted living facility had tested positive for the COVID-19 coronavirus. The resident is currently being cared for in a local hospital. Brookdale Oak Park, 1111 Ontario Street, a retirement and assisted living facility operated by ARC Holley Court, LLC, has been ordered to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees. In addition strict measures preventing the acceptance of any new assisted living residents are in place. Other measures include the prohibition of any visitors and canceling events or gatherings within the facility.

Failure to comply with the public health order is a Class A misdemeanor under state law, which carries a maximum penalty of a year in jail and a \$2,500 fine. In addition, the facility could lose its license and face civil liability.

It is noted this is the second case in an assisted living setting. As part of the April 1, 2020 Daily Status Report Director Charley reported that a resident of Oak Park Oasis, 625 North Harlem Avenue, Oak Park, also a retirement and assisted living facility had a resident test positive for the COVID-19 coronavirus and that an Order was issued to the Oasis to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees.

Director Charley announced during the April 6, 2020, Village Board meeting that two positive COVID-19 tests have also been reported – one each - at the Oaks, 114 S Humphrey Ave (on March 28) and Heritage House, 201 Lake Street (on April 1). The Oaks and Heritage House are unaffiliated. Each is an apartment building and all units have age and income restrictions. Because of privacy laws, no additional information can be released about the individuals. Apartment buildings, even with age and income restrictions are not subject to the CDC/IDPH guidance for assisted living/nursing homes.

## **Village Board Meeting April 6, 2020**

As a part of the Village Board remote participation meeting yesterday at 7 p.m. a number of important actions were taken by the Board, including approval of Resolution 20-124, Extending the Declaration of an Emergency Affecting the Public Health thru May 5, 2020, changes to parking fees (see below) and late fees for delinquent water bills (also detailed below).

## **Temporary Parking Permit Fee Reductions**

The Village has decreased quarterly parking permit fees for Lots, Garages and Overnight Zones by 50 percent for parking permits with start dates of April 1<sup>st</sup> and May 1<sup>st</sup>. This action was authorized by the Village Board to provide Emergency Assistance due to the financial hardships attributed to the COVID-19 outbreak.

## **Suspending most On-street, Overnight and Daytime Parking Restrictions Until May 5<sup>th</sup>**

On-street, overnight and daytime parking restrictions will not be enforced on most Oak Park residential streets through Tuesday, May 5 to accommodate residents' changing routines as a result of the COVID-19 emergency. Please keep in mind restrictions are not lifted in metered or

pay station spaces, or paid overnight permit areas, including posted on-street zones and lots. All other parking regulations related to traffic and public safety such as no parking here to corner or between signs remain in effect.

#### **More Free Parking in the Avenue Public Parking Garage**

Village Board approved an Ordinance increasing free parking from 1 hour to 1.5 hours at the Avenue Garage at North Boulevard near Oak Park Avenue which is available during the Lake Street Streetscape Project.

#### **Suspension of Late Payment Penalties on Water Bills**

Due to the COVID-19 disease outbreak, staff is recommending that the Village waive and suspend the 10% late payment penalty on water charges set forth in Village Code Section 26-2-3 for water/sewer bills due on or before December 31, 2020. Pursuant to Code Section 26-2-3, the late payment penalty is only applied on the portion of the water/sewer bill that pertains to water supplied (usage) charges. The sewer and refuse fee portion of the bill has always been excluded from the late payment penalty.

#### **Emergency Operations Center (EOC)**

To ensure operational response during a local emergency, the Village's local emergency operating plan, provides for "the Village Manager or his/her designee has the authority to activate the EOC and order designated EOC staff members to report to the EOC." On April 7, the EOC moved from a Level 3 – Partial Activation to a Level 2 - Full Activation. This full activation follows the Village Board's approval of Resolution 20-124, extending the Declaration of an Emergency Affecting the Public Health thru May 5, 2020. The full activation is effective immediately and is done in part to recognize and document that nearly all Village resources are being directed to the response of the COVID-19 worldwide global pandemic as defined by the World Health Organization and as such, the Village cannot rely upon other units of local government via traditional mutual aid channels as would be the case if Oak Park were experiencing an isolated public emergency. Due to the nature of this worldwide pandemic, the Village must alternatively coordinate systems, procedures and practices in accordance with the guidance of the Centers for Disease Control and Prevention (CDC), the Illinois Department of Public Health (IDPH), Cook County Department of Emergency Management and Regional Security as well as other Oak Park local units of government, neighboring communities and social service providers. In addition, the full activation recognizes that the Village will seek County, State and Federal resources, both financial and material in its emergency response.

During the pandemic, the Village's Emergency Operations Center (EOC) functions virtually within the National Incident Management System (NIMS) which provides a common, nationwide approach to enable the whole community to work together to manage all threats and hazards. Under the Federal Emergency Management Agency (FEMA) NIMS applies to all incidents, regardless of cause, size, location, or complexity.

#### **Liquor License Information**

Liquor licenses are renewed on a rolling 12 month basis from the date of the original approval and the Village on average has between 3-4 renewals each month. During the Illinois Stay at Home



Order, a business that has closed business and whose license is expiring during this time would not be required to renew their license and could wait until they reopen to renew their license for the next 12 month period. Restaurants that are currently open are allowed to sell alcoholic liquors in their original containers only as part of a delivery or curbside pick-up as long as they have a current liquor license for the sale of such beer/wine products in the original container.

### Senior Housing Case

It was reported that a resident of a local a retirement and assisted living facility had tested positive for the COVID-19 coronavirus. The resident is currently being cared for in a local hospital. Berkeley Nursing and Rehabilitation Center, 6909 North Ave, Oak Park, Illinois, a skilled nursing facility operated by Berkeley Nursing and Rehabilitation Center LLC, has been order to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees. In addition strict measures preventing the acceptance of any new residents or rehab patients are in place. Other measures include the prohibition of any visitors and canceling events or gatherings within the facility.

It was additionally reported three new positive COVID-19 cases at the Oak Park Oasis, 625 North Harlem Avenue, Oak Park (all new cases are hospitalized). While these cases are included in the total cases reported about in Oak Park today, privacy precludes reporting of any additional information on the individuals. This brings the total to four cases at the. Staff continues monitor, work with and support the Oasis and its compliance with the Public Health Order that was issued by Director Charley on March 31, 2020 following the first reported case at the facility. The Village was additionally supported by the Illinois Department of Public Health yesterday as a call was held with representatives of Oasis including Susan Bledsoe with the Oasis/ ICare Consulting (corporate representative), Deji Adegoye the local Oasis Administrator, Evonda Thomas-Smith the Assistant Director – Illinois Department of Public Health and two other representatives of IDPH as well as Public Health Director Charley and several additional members of Village staff as everyone is working cooperatively to address this significant situation at the Oasis facility.

## **Rental Assistance Update**

The Village has a long standing program in partnership with Housing Forward to provide rental assistance to Oak Park residents facing homelessness and is the current agency being promoted in the community for rental assistance programs. Currently, Housing Forward has three main funding sources. The first is the State of Illinois Homelessness Prevention funds which provides up to 3 months of rental assistance. This program does have two state requirements that limit eligibility; the applicant must have a source of income and not received funds in the last 2 years. Housing advocates are encouraging the state to eliminate these requirements during the COVID-19 crisis. The second source of funding is Emergency Solutions Grant funds (ESG) provided by the Village, as well as from Cook County. The one barrier to utilizing these funds had been the fair market rent levels established by the US Department of Housing and Urban Development which in some situation establish rent levels too low. The Village has made a request to HUD to waive the fair market rent levels during the COVID-19 crisis, and therefore, it is no longer a barrier. Additionally, the ESG funds awarded to Cook County were increased by HUD and Housing Forward is expected to receive a substantial increase in funding from Cook County ESG. The third source of funds is the Flexible Rental Assistance Program which is funded by the Village's Affordable Housing funds and under Resolution 20-124 adopted by the Village Board on April 6, 2020 which extending the Declaration of an Emergency Affecting the Public Health thru May 5, 2020 funds unspent in 2019 are being earmarked for Housing Forward as needed after Illinois Homelessness Prevention Funds and ESG funds are exhausted. Finally, Village staff is in contact with HUD to determine if the Village can use the CDBG CARES fund for additional rental assistance via Housing Forward based upon local needs established through the HUD award process.

## **Social Services**

During this week's social service call, the following information was reported: The Oak Park Township will be delivering 10 pack meals to 300 residents this week. The Oak Park Park District reported they are working with community volunteers to sew face masks for non-health workers. The Park District asked each agency to let them know how many masks they would like. The Oak Park Public Library has posted information for students dealing with online learning. The School Districts reported making plans for continued elearning through the Governor's Stay at Home order. The Oak Park Community foundation directed non-profits to [www.chicagocovid19responsefund.org](http://www.chicagocovid19responsefund.org) to learn about funding opportunities. The community congregations are planning an online service of comfort on April 30 which will be a multi-faith gathering. The Oak Park Chamber of Commerce is conducting a business impact survey. Beyond Hunger saw a 35% increase in food requests from the week before. They have implemented safety officers on each shift to ensure adequate social distancing practices are maintained for volunteers. Housing Forward is working with volunteers to provide breakfasts and lunches to participants and catering evening meals. Thrive reported an increase in online counseling.

Oak Park Public Health Director Mike Charley today announced the death of a second Oak Park resident believed to be related the COVID-19 coronavirus. The individual was a man in his 50s. The official cause of death will be determined by the Cook County Medical Examiner. The Village organization expresses its condolences to the man's friends and family.

### Senior Housing Case

One additional new positive COVID-19 cases at the Oak Park Oasis, 625 North Harlem Avenue, Oak Park (the new case is hospitalized). This brings the total to five cases originating at the Oasis - a retirement and assisted living facility. Staff and the Illinois Department of Public Health (IDPH) continue to work with and support the Oasis. The Oasis continues to follow a number of important protocols including screening the temperature of all facility employees, all deliveries to the facility are conducted outside and delivery personnel may not enter the facility. Visitors and gatherings of residents at the facility continue to be prohibited.

### Village Employee Tests Positive

The Village received notification that a third Oak Park Police officer has tested positive for COVID-19. According to the Public Health Director, the employee chose to self-quarantine upon exhibiting symptoms of COVID-19 and has remained out of the workplace since late-March. Pursuant to Village personnel policies, an organizational notice was issued and it is noted that there were no contacts with staff or the public that required notice of quarantine. Because of privacy laws, no additional information can be released. The Village continues to evaluate safety measures for all staff and continues enhanced cleaning protocols. All of our first responders have employee temperature screenings before working as an additional precautionary measure.

The Oak Park COG held a GoToMeetings call yesterday, April 8th combined with the River Forest and Forest Park COGs. The COG is the chief elected and chief appointed official from each taxing body and has allowed for important discussion around shared actions and shared information.

## Small Business Program

The third death of an Oak Park resident, a woman in her 90s, was reported and believed to be related the COVID-19 coronavirus. The official cause of death will be determined by the Cook County Medical Examiner. The Village organization expresses its condolences to her family.

### Senior Housing Status

Three additional positive tests were reported by residents of Brookdale Oak Park, 1111 Ontario Street and brings the total cases to five at Brookdale, which was issued a Public Health Order April 7 to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees following the first positive test from a resident of the facility. Public Health staff continued to work closely with the organization's management and IDPH regarding guidance.

### Social Services Update

The YMCA still has spaces available in its emergency childcare program for essential workers. They expect to continue the program through at least the end of the school year. It was also reported that Thrive is part of the Governor Pritzker's mental health initiative "Call4Calm," which was launched Saturday by the state's Human Services Mental Health Division. Illinois residents wanting to speak to a mental health care professional can text the word "TALK" to 552020, and the service is free to use.

### Village Vehicles License Renewals

Pursuant to 15-4-1 of the Village Code, current vehicle licenses are due to expire July 14, 2020 and renewal notifications would historical be starting in the coming weeks. We are extended that deadline to September 14, 2020 because many Oak Park residents have limited income during the COVID-19 crisis and this delay will provide residents with financial relief at this time. This is being done under the Village Manager's authority in Resolution 20-124, adopted April 6, 2020, which extended the Village's "Declaration of Emergency Affecting the Public Health" originally declared on March 13, 2020 due to the outbreak of the COVID-19 disease. ### Updated Information on Testing Sites

Public Health Director Charley has shared the following about a new COVID-19 testing site near Oak Park. As a general recommendation, individuals should contact their medical healthcare provider directly to inquire about testing options.

Walgreens is operating a COVID-19 testing facility at the former Walgreens store located at North Ave & Mobile in Chicago (where Ridgeland Ave meets North Ave). This location (as well on one in Bolingbrook) provides Drive-Up COVID-19 testing through a self-administered nasal swab, at no-cost to the patient. The test results will be communicated to the patient quickly (1-2 days). Walgreens will also be reporting test outcomes to HHS and to IDPH so they are able to track as required. Individuals that are interested in getting tested should go online to [www.walgreens.com/coronavirus](http://www.walgreens.com/coronavirus). The guidelines for being tested at each of the Walgreens sites align with HHS guidelines where testing is being prioritized for individuals that have symptoms and are/have: Healthcare workers, first responders and those 65 and older with symptoms; and those with pre-existing health condition with symptoms.



### Management Council

An online meeting of management council (the chief appointed official for each taxing body) was held on Tuesday April 14 to allow for ongoing dialogue amongst the organizations about coordinated efforts in response to COVID-19.

### Council of Governments (COG)

The Oak Park COG held a GoToMeetings call this morning, April 15 combined with the River Forest and Forest Park COGs. The COG is the chief elected and chief appointed official from each taxing body and has allowed for important discussion around shared actions and shared information. The group continues to highlight the high level of collaboration in the shared community response to the ongoing COVID-19 pandemic.

### Cases related to Employees in Local Nursing Home

Two employees of a local retirement and assisted living facility have tested positive for the COVID-19 coronavirus. Belmont Village, 1035 Madison St, Oak Park, Illinois, an assisted living and memory care facility operated by Belmont Village Oak Park, L.L.C. ("Belmont Village"), has been order to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees. In addition strict measure related to screening the temperature of all facility employees upon the start and end of any applicable work shift are in place as well as communication to its employees, contractors, residents, patients, and immediate family members or other emergency medical registered contacts of residents or

patients of the daily status of the ongoing situation resulting from these employee positive test results related to COVID-19 is required.

### Census Update

The Village of Oak Park's current response rate to the Census is 57.4% which is higher than the State of Illinois response rate (53.4%) but far below our final 2010 rate of 74.6% (there are not records to show a comparison to the same point in time in 2010). A significant concern with this response rate is related to Oak Park's high apartment census tracts (depicted in the map below as light blue and yellow). Specifically, if the Federal government delays the final census count to the fall of 2020 and does a big push to go door to door in the fall, the residents they contact may not be counted as anyone in our who became a new resident over the summer, will not be counted as they were not a resident on April 1. Oak Park traditionally experiences a high rate of apartment turnover/moves in the summer months. The potential result will be a significant undercounting of our rental population residents due to these anticipated summer moves. In order to try to increase our counts now, we are going to start a targeted census campaign to landlords to hopefully help reach tenants in their buildings. We are also looking at using our grant funds to put up yard signs in the lower response rate census tracts. We have reached out to the other taxing bodies communication directors as well.

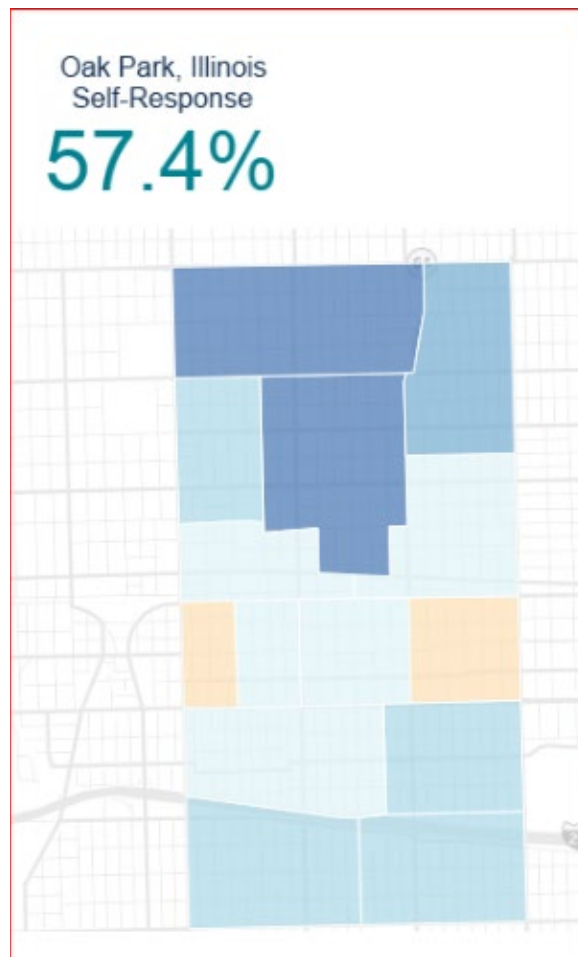

### Upcoming Village Sponsored Community Events & Block Parties

Staff has been evaluating future Village sponsored events that traditionally are held in beginning in May in conjunction with public health factors. We anticipate updating the public late next week on our 2020 events including Day in Our Village, Summer Youth Employment program as well as the Fourth of July Parade and Fireworks Celebration. In regards to the 2020 Farmers Market, the Village is working to develop plans for how to hold the Market as the availability of fresh produce in the community is important. Cameron Davis, Asst. Director of Development Customer Services will be the Staff Liaison to the Farmers Market Commission this year. There are a number of issues related to public health and social distancing that must be addressed in order to get the Market operational. Details will be ready in the coming weeks. Block party permits are not being issued for April and a decision regarding May block parties will be announced soon. In the event future block parties are permitted, they will be accompanied by social distancing requirements. All Fire Department visits to block parties are being eliminated for 2020 and it is likely bouncy houses will not be allowed this year.

### **Cases related to Long-Term Care and Assisted Living Facilities**

The Oak Park Public Health Department has been consistently reporting cases of residents in Oak Park senior facilities where Assisted Living or skilled nursing care is provided. The Village of Oak Park has five facilities which meet the above definitions (it is noted that some of the Long Term Care and Assisted Living facilities in Oak Park also have within their property some independent living units.) On Friday, April 17, 2020, the State of Illinois Department of Public Health began reporting on its website summary data for Long Term Care and Assisted Living. In order to improve the accessibility to this information, Director Charley is also including a chart in the daily bulletin, posted on the Village's website with the summary data, by facility and including positive tests results for residents, resident fatalities and employee positives (which may not be an Oak Park resident). I will include the chart in this report as well.

When there is a single resident case or at least two employee cases, the Oak Park Public Health Department has issued the facility a Public Health Order to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees. Failure to comply with the public health order is a Class A misdemeanor under state law, which carries a maximum penalty of a year in jail and a \$2,500 fine. In addition, the facility could lose its license and face civil liability. In addition, staff is working closely with each facility to manage compliance with the Order.

Upon appointment of Interim Deputy Fire Chief Joseph Terry on March 13, 2020 he was assigned to support the Public Health Response to COVID-19 and focus on the Village's senior housing facilities. In addition to those listed above, the Village is also home to four independent living senior facilities – which are essentially apartment buildings that have age restrictions (and some income restrictions) in order to become a resident in the facility. Independent living facilities are not licensed by the State of Illinois and therefore not contained in the new IDPH reporting. Oak Park's Public Health Department is working with the management the four independent living facilities (Ryan Farrelly Apartments, Heritage House, The Oaks and Mills Park Tower) to provide public health guidance and resources.

### **Oak Park Homeless Coalition**

The Oak Park Homeless Coalition, a multi-stakeholder group comprised of 50-plus organizations working to end homelessness in Oak Park will be meeting on Thursday, April 23, 2020. The remote participation meeting will include representatives from the Chicago Coalition for the Homeless and

Housing Action Illinois who will provide state and federal updates on COVID-19 resources and initiatives. Housing Forward is reporting an increase in services of approximately 30% for both people experiencing homelessness and requests for homeless prevention services such as rental assistance. Development Customer Services staff will be a part of the call.

#### **IDPH COVID-19 Crisis Grant**

The Village will be applying for a newly available IDPH COVID-19 Crisis Grant. The Grant will cover expenses related to the Public Health Department's response to the COVID-19 pandemic. The Grant application is made by the Public Health Department and covers the period from March, 16 2020 through March, 15 2021 and the funding available to the Village is \$49,820.

Oak Park Public Health Director Mike Charley reported that a resident of a local retirement and assisted living facility has tested positive for the COVID-19 coronavirus. The resident is currently being cared for in a local hospital. Oak Park Arms, 408 South Oak Park Avenue, Oak Park, Illinois, a senior independent living and assisting living rental retirement community operated by Oak Park Arms, L.L.C. ("Oak Park Arms") has been ordered to take specific steps that comply with Illinois Department of Public Health (IDPH) and Centers for Disease Control and Prevention (CDC) guidance for protection of the health of facility's residents and its employees. In addition strict measures preventing the acceptance of any new assisted living residents are in place. Other measures include the prohibition of any visitors and canceling events or gatherings within the facility.

### Management Council

An online meeting of management council (the chief appointed official for each taxing body) was held on today and allowed for an ongoing dialogue amongst the organizations about coordinated efforts in response to COVID-19 as well as planning discussions for short, medium and long range planning efforts.

### Village Staffing

During the prior work week, 190 village employees continued to work full time on site (primarily public health, fire, police and village management); 42 employees work full time remotely (primarily administrative and operational support); 73 employees work reduced hours on site (primarily public works and administrative to maintain discreet work groups); 14 employees worked reduced hours remotely and 25 employees were deemed non-essential for the work week and did not work. All of the above currently filled positions remained on the Village's payroll without reduction to compensation and benefits.

### **New Public Health Guidance – Cloth Face Coverings**

In advance the May 1<sup>st</sup> State requirement for the use of cloth face coverings in public, Oak Park Public Health Director Mike Charley has issued guidance today that he is recommending residents begin this practice now and in advance of the State's mandate. Director Charley stopped short of a mandatory order and reminded the public that the use of face coverings does not supplant or diminish the need for all residents, employees and workers in Oak Park and all visitors to Oak Park to practice social and physical distancing in all settings and individuals who are feeling sick need to stay home.

The Village additionally asks each resident to be mindful of the how information and rhetoric about the pandemic may contribute to biases against specific groups based upon race or other identifying features. Everyone is reminded that the use of cloth face coverings is being done by individuals in our community to keep themselves and their families safe and healthy. Remember to be kind to everyone during these unprecedented times.

Residents of Oak Park in need of a cloth face covering may go the Oak Park Police Station lobby beginning Saturday, April 25, 2020. Subject to proof of Oak Park residency a mask will provided and is limited at this time to one per person, due to limited supplies. The Village is working with local partners to increase availability.

The Village is grateful to the Park District of Oak Park and its "sewing" volunteers for providing the current supply being made available to individuals in need.

### **New Public Health Guidance – Special Events**

In support of continued efforts to reduce the community spread of COVID-19, Oak Park Public Health Director Mike Charley issued a Public Health Order today prohibiting all Special Events and public gatherings of ten (10) or more persons scheduled for the months of May and June 2020. The Order identifies "special events" as defined in Section 30-1-1 of the Oak Park Village Code including: gatherings or assemblies that are conducted entirely or partially on public property at a specified location for activities such as, but not limited to, markets, ceremonies, celebrations, shows, festivals, exhibitions, pageants, circuses, entertainment, theatrical productions, sidewalk sales, sporting events, games or similar activity. The order also prohibits in May and June

organized, nonpermanent, public gathering or assembly on public property and private property and including but not limited to ceremonies, celebrations, shows, festivals, exhibitions, pageants, circuses, musical concerts, and theatrical productions, sidewalk sales, sporting events, competitions or games in public parks.

Director Charley noted that for indoor events/gatherings, such as school events, faith-based events and similar events, planned for June 2020 would be issued at a later date (as the Governor's pending extension of the Stay Home order will address May events). Finally, Director Charley noted that he encourages any special events that are scheduled to occur in July 2020 to be canceled or postponed. Assistant Village Manager/Human Resources Director Kira Tchang is communicating and working with all Special Event Permit Holders from 2019 and 2020 regarding this information.

### Management Council

An online meeting of management council (the chief appointed official for each taxing body) was held on today and allowed for an ongoing dialogue amongst the organizations about coordinated efforts in response to COVID-19 as well as planning discussions for short, medium and long range planning efforts.

### Meal Distributions

Oak Park and River Forest High School District 200 and Oak Park Elementary School District 97 also continues to distribute weekly pick-up of breakfasts + lunches to students in need during this important time. Both D200 and D97 are providing meals for any student in need and are not limiting the meals to students already registered for "free and reduced" lunch programs. Pick-up days and location information can be found at the student's own school website.

The Township, with funding from Age Options and help from the Village and community volunteers, has had eight bulk meal distribution events between 3/26/20 and 4/27/20 focused on seniors. On eight different days, meals have been both delivered to homes and distributed drive-thru style in the Township parking lot. Meals are boxes of frozen meals (5 packs) or shelf-stable meals (5 or 10 packs depending on provider). The total number of meals delivered in these mass distributions is now over 22,000.

This is noteworthy since before the pandemic, on average, the Township served 65 hot meals per weekday at our Congregate Meal site and delivered 195 per day to Home Delivered Meals participants. Last Fiscal Year, we served over 62,000 meals the entire year in these two programs.

The Village has helped to share information about the availability of meals and other services for vulnerable members of our community. In addition, staff from Development Customers Services has participated in meal deliveries and Police staff has assisted with traffic control at the drive-thru operation.

### **Interim Deputy Fire Chief Infectious Disease**

The appointment of Joseph Terry as Interim Deputy Fire Chief for Infectious Disease has been extended through June 5, 2020. The initial appointment was made March 13 through May 1st following a Side Letter agreement with the IAFF Local 95 to address issues related to wages, benefits and the Fire Fighters Promotional Act which is a state law governing the competition promotional process for all fire fighters under the rank of Deputy Chief. Interim DC Terry has been working with the Public Health Director with a focus on senior long term care facilities and other matters related to the Village's response to COVID-19.

### **Extension of relaxed enforcement of many Parking Restrictions**

On-street, overnight and daytime parking restrictions, including restrictions for street cleaning, will not be enforced on most Oak Park residential streets to accommodate residents' compliance with the Stay Home order as a result of the COVID-19 emergency. Restrictions currently are scheduled to resume at 2:30 a.m., Tues., June 2. Please keep in mind restrictions are not lifted in metered or pay station spaces, or paid overnight permit areas, including posted on-street zones and lots.
