

**AMENDMENT TO AGREEMENT FOR MUNICIPAL SOLID WASTE, RECYCLING
AND LANDSCAPE WASTE COLLECTION**

This Amendment to the Agreement for Municipal Solid Waste, Recycling and Landscape Waste Collection is made and entered as of this ____ day of _____, 2020 by and between the Village of Oak Park ("Village"), and Waste Management of Illinois, Inc. ("Contractor").

Recitals

1. The Village and Contractor executed an Agreement for Municipal Solid Waste, Recycling and Landscape Waste Collection on September 21, 2016 (the "Agreement").
2. The Village and Contractor now desire to amend the Agreement.

Amendments

The Village and Contractor hereby agree to amend the Agreement as follows:

1. **Definitions.** Section 2(F) shall be deleted and the following substituted therefor:
 - F. **Fall Leaf Collection.** Fall leaf collection means the raking into the street, collection and removal of leaves during the fall for the period of six weeks.
2. **Fall Leaf Collection.** Section 8(A) shall be deleted and the following substituted therefor:
 - A. **Collection Period.** The Contractor shall collect leaves during the fall season for a period of six weeks pursuant to the Village's fall leaf collection program as set forth in this Agreement. The collection period during which the Contractor shall collect leaves will begin the first week of November and go through the second full week of December annually. For 2020, the dates are November 2 and go through December 11, 2020. The collection dates for 2021 shall be mutually agreed upon by the parties. If collection must be prolonged due to inclement weather, the Village reserves the right to extend the collection program at no additional cost provided, however, that leaf collection shall not be performed for more than six individual weeks. Said extension shall require the postponement of collection for a given week and adding a week after the originally scheduled completion date.
3. **Fall Leaf Collection.** Section 8(F) shall be deleted and the following substituted therefor:
 - F. **Leaf Collection Cost.** The Village shall pay the Contractor One Hundred Eighty-Nine Thousand Five Hundred and Seventy-Seven Dollars (\$189,577.00) upon the successful completion of the Contractor's collection and removal of leaf piles during the 2020 fall leaf collection program; provided, however that the Parties acknowledge that the Village is responsible for raking the leaves into piles in the street gutter for collection. For the 2021 fall leaf collection, the Village shall pay Contractor an amount

adjusted per the Annual Cost Adjustment as outlined in Section 13(B) of the Agreement.

4. No Other Changes. Except as specifically modified herein, all other terms of the Agreement will continue in full force and effect.
