RENEWAL OF THE CONTRACTOR SERVICES AGREEMENT BETWEEN THE VILLAGE OF OAK PARK AND OCCUPATIONAL HEALTH CENTERS OF ILLINOIS, P.C., D/B/A CONCENTRA MEDICAL CENTERS AND AUTHORIZING ITS EXECUTION

- 4. **EFFECTIVE DATE.** This Renewal shall be effective on the last date of its execution by one of the Parties as reflected below.
