My daughter has been in Mary's care since September 2017, and I look forward with anticipation for my son to start at MASI along with his sister once they reopen in the new space. It's strange to simply describe what MASI and Mary provide as "services," as the community Mary has created has become essential to our family.

Mary manages an extremely well-run daycare. Her staff is professional, responsible, and virtual miracle workers in the way they approach all of the challenges inherent to dealing with a group of toddlers! I always remark that the teachers at MASI strike a perfect balance with being authority figures that the children listen to and respect, while also being warm and loving sources of comfort. Countless times I've seen my daughter and her friends fall into their laps for hugs. But they are also crystal clear about rules. At home, my daughter recreates their line-up system, and when we play school, she loves to pretend to be Ms. Mary and lead circle time just like her teacher. This shows me that she has responded positively to the structure that MASI provides. She has learned so much at MASI, but most importantly to me, she has adults in her life that she loves and trusts. I know these relationships are important pieces to her well-being, and the emotional foundation for her future. I couldn't be more grateful.

When considering all of the concerns about sending my kids back to a situation where they will be in contact with more people, I don't think I would have more confidence in anyone but Mary Lubinus to prioritize our children's health. She is meticulous about safety, cleanliness and hygiene. One of my daughter's first words in Spanish was the word for hand sanitizer! If I were to use clichés, I'd say Mary "runs a tight ship" and does things "by the book." I know she wants to move MASI to a larger space where it will be easier to follow new guidelines, and I appreciate this planning. I have no doubts that in the new space, MASI will be as well-run as it always has been.

I understand that Madison being a busy street presents a concern for the drop off and pick up procedures. I don't share this concern for two reasons. First, the handful of times I attended programming at this location when it was Academia, parking, entering and leaving with a small toddler was never a problem. Second, and more importantly, parking, pick-up and drop-off at MASI's previous location was extremely well-executed. The logistics of that space was also not simple, but Mary is so organized and proactive, parents were well-informed about parking restrictions in her lot, temporary closures due to construction, garbage pickup or other maintenance. Communication with Mary is easy and that makes for seamless transitions. On rainy days, she was outside with an umbrella as we arrived. When my son was a newborn, Mary or another teacher would bring my daughter to the car so I didn't have to disturb him. They are also able to do this because the team works so well together, coordinating all of their simultaneous responsibilities. Often, if my daughter was reluctant to leave (tantrumming) because she was in the middle of something fun, or didn't want to leave her teachers, they found creative ways to deescalate her, accompanying her to my car, coaxing her safely into her car seat. Several times we pulled away with calls through the window of "Chao! Gracias! I love you!" Rather than worry this process will be harder in their new location, there just might be more foot traffic to overhear my kids' professions of love for their MASI teachers.
