## ORDINANCE

AN ORDINANCE AMENDING CHAPTER 3 ("ALCOHOLIC LIQUOR DEALERS"),
ARTICLE 8 ("LIST OF LICENSES FOR EACH LICENSE CLASS"),
SECTION 3-8-1 ("NUMBER OF LICENSES PERMITTED TO BE ISSUED PER LICENSE
CLASS"), AND SECTION 3-8-2 ("LICENSES BY NAME AND ADDRESS PER LICENSE")
OF THE OAK PARK VILLAGE CODE FOR THE ISSUANCE OF A HOTEL CLASS A-2 SUBSIDIARY
LIQUOR LICENSE TO LA NOTTE VENTURES, INC., DBA LA NOTTE RISTORANTE ITALIANO

**WHEREAS,** the Village of Oak Park ("Village") is a home rule unit of government as provided by the provisions of Article VII, Section 6 of the Illinois Constitution of 1970;

WHEREAS, as a home rule unit of government, the Village is expressly empowered to perform any function pertaining to its government and affairs, including, but not limited to the power to regulate for the protection of the public health, safety, morals and welfare;

WHEREAS, La Notte Ventures, Inc., DBA La Notte Ristorante Italiano ("La Notte") has applied for a Hotel Class A-2 Subsidiary liquor license for the property located at 1120 Pleasant Street, Oak Park, Illinois;

**WHEREAS,** the A-2 liquor license for the property at 1120 Pleasant Street is currently held by Philander's, LLC, DBA Barclay's American Grille and La Notte would be the successor licensee;

WHEREAS, La Notte currently holds a Restaurant Class B-1 liquor license for the property located at 108 North Marion Street, Oak Park, Illinois, and such license would be surrendered and null and void upon the issuance of the Class A-2 license set forth herein;

WHEREAS, at its special meeting of October 12, 2020, the Village's Local Liquor Control Review Board ("LCRB") unanimously voted to recommend to the Local Liquor Control Commissioner ("Commissioner") that La Notte's application be granted and that a Class A-2 liquor license be issued and the Commissioner concurs with this recommendation;

WHEREAS, in order for the Commissioner to issue the Class A-2 liquor license, the Oak Park Village Code ("Village Code") must be amended to allow for the issuance of the liquor license; and

**WHEREAS,** the Board of Trustees find that it is in the best interest of the Village to amend the Village Code so that a Class A-2 liquor license may be issued to La Notte.

**NOW THEREFORE, BE IT ORDAINED** by the President Pro Tem and Board of Trustees of the Village of Oak Park, Cook County, Illinois, in the exercise of their home rule powers, as follows:

**Section 1. Recitals Incorporated.** The above recitals are incorporated herein by reference as though fully set forth.

**Section 2. Village Code Amended.** Chapter 3 ("Alcoholic Liquor Dealers"), Article 8 ("List of Licenses for Each Class"), Section 3-8-1 ("Number of Licenses Permitted to be Issued Per License Class"), and Section 3-8-2 ("Licenses by Name and Address Per License") of the Oak Park Village Code are amended by deleting the overstricken language and adding the underlined language to read as follows:

## 3-8-1: NUMBER OF LICENSES PERMITTED TO BE ISSUED PER LICENSES CLASS:

B-1 No more than eighteen (18) seventeen (17) Class B-1 licenses shall be issued.

## 3-8-2: LICENSES BY NAME AND ADDRESS PER LICENSE:

CLASS A-2 <u>La Notte Ventures, Inc., DBA La Notte Ristorante</u> 1120 Pleasant Street <u>Italiano</u> <del>Philander's LLC, DBA Barclay's American Grille</del>

Class B-1 La Notte Ventures, Inc., DBA La Notte Ristorante 118 North Marion Street

Section 3. License Subject to Remittance of Alcoholic Liquor Purchase at Retail, Privilege Tax. Any liquor license granted to La Notte pursuant to this Ordinance shall be strictly subject to the payment of the Village's "Alcoholic Liquor Purchase at Retail, Privilege Tax" set forth in Chapter 23A ("Taxes"), Article 2 ("Alcoholic Liquor Purchase at Retail, Privilege Tax") of the Village Code. Failure to remit payment of the tax shall subject the applicable liquor license to suspension or revocation pursuant to Section 23A-2-10 of the Village Code.

**Section 4. Severability and Repeal of Inconsistent Ordinances.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance. All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 5. Effective Date.** This Ordinance shall be in full force and effect after its approval, passage and publication as provided by law.
