#### 4. Proposed Scope of Services

Perspectives is well equipped to meet the requirements as set forth in the RFP and outlined below.

Perspectives is staffed with experienced therapists who possess the education, training, certification, licensure and a demonstrated ability to perform wellness and behavioral assessments.

Perspectives will provide one-on-one mental and behavioral wellness assessments facilitated by our mental health professionals for all sworn officers.

With our staff and multiple office locations, Perspectives will complete all assessment sessions within each contract year and provide ongoing attendance reports.

All conversations shared during the wellness checks will be confidential except when and where required by law.

Perspectives' will facilitate the assessment sessions at whichever of the below locations are most convenient for the officers.

Perspectives' experience has shown that our mental health wellness assessment programs proactively identify if, where and when behavioral and mental health support is needed by first responders. While police departments may require a physical, they typically do not require a mental health wellness assessment. This program would provide an opportunity for Oak Park's police officers to process any challenges or traumatic events they have faced, are currently facing or may experience in their career.

These assessments will be facilitated by Perspectives counselors that specialize in working with first responders. We understand that confidentiality is very important and will not disclose any information without a signed release of information. If a release of information is warranted and signed by an officer, information will only be disclosed to the individuals outlined on the release that the officer signed.



Assessments will be held at one of Perspectives' office locations outlined in this proposal and it is recommended to schedule the sessions with a window of time between them to reduce the risk of officers coming in contact with other officers leaving their session. This is important as officers have been known to become emotional during their session and we want to reduce the risk of such officers feeling vulnerable by coming into direct contact with a colleague while in this state following their session.

Perspectives' experience in conducting wellness assessments on first responders has shown the below to be areas that typically should be assessed on an annual basis:

- Substance use (as a coping mechanism due to trauma they may have experienced or been exposed to)
- Marital/family/relationship concerns in regard to communication
- Addictions and concerns with eating, such as overeating and gambling
- Open time for the officers to discuss anything such as any issues they want to touch on (personal or work related) or to discuss any events they were involved in that they want to process.
- Additional areas may be assessed by the counselor as requested by the Village of Oak Park.

At the beginning of each month, Perspectives' Account Executive for this program will inform the designated individual at the Village of Oak Park, typically the Chief of Police, who has completed their assessment in the month prior. If a different frequency of updates is desired by Oak Park, Perspectives is open to exploring this further.

The Perspectives counselor will make sure to provide referrals to the appropriate resources for the officers they are assessing, if clinically appropriate. As Perspectives also provides Oak Park's Employee Assistance Program (EAP), the assessed officers may continue counseling through their EAP benefit at no cost to them or the village (covered under current EAP agreement). If this is something an officer expresses interest in, the counselor will direct the officer on how best to utilize the EAP resources. Additionally, all officers have access to the wealth of online and telephonic resources provided via the EAP and usage of these resources will be recommended if and when appropriate.

#### 5. Proposed Schedule of Implementation

Perspectives has a 17-year relationship with the Village of Oak Park which, when coupled with our experience and resources related to conducting wellness assessments for first responders, enables us to implement the program outlined herein in an efficient and seamless manner.

The recommended process would be as outlined below:

- Phase 1 Setup
  - Identifying who will be Perspectives' primary contact (program lead) at Oak Park for this program
  - Working with Oak Park to develop internal messaging and communication for the program
  - Aligning on workflow processes and responsibilities for both parties

- Reviewing officer's schedules and where they live to determine an annual calendar identifying which location is most convenient and when each officer will go through their required assessment to ensure each sworn officer goes through one (1) assessment every 12 months.
- Estimated time Two (2) weeks assuming access to and availability of village resources
- Phase 2 Implementation/Ongoing
  - Perspectives' Account Executive and/or Oak Park's program lead will schedule the assessments to be completed each month at least two (2) weeks before the month begins.
  - Oak Park's program lead will inform and remind officers of their scheduled assessments and will update Perspectives' Account Executive, or the assigned counselor, if there are changes or reschedules required at least 48 hours in advance.
