

**AN AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT BETWEEN  
THE VILLAGE OF OAK PARK AND GINO'S HEATING & PLUMBING INC. FOR  
EMERGENCY WATER AND SEWER REPAIR IN AN AMOUNT NOT TO EXCEED \$30,000.00**

**THIS AMENDMENT TO THE INDEPENDENT CONTRACTOR AGREEMENT DATED JULY 8, 2020** (hereinafter referred to as the "Amendment") between the Village of Oak Park, an Illinois home rule municipal corporation, and Gino's Heating & Plumbing Inc., an Illinois corporation, is entered into this \_\_\_\_ day of November, 2020 (collectively referred to as the "Parties").

**RECITALS**

**WHEREAS**, the Parties entered into an Independent Contractor Agreement between the Parties dated July 8, 2020 (hereinafter referred to as the "Agreement"); and

**WHEREAS**, the Parties seek to amend the Agreement pursuant to this Amendment.

**NOW, THEREFORE**, in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.

2. **AMENDMENT TO AGREEMENT.** Section 2 ("Scope of Work") of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

Contractor shall perform the work for the Project in accordance with its Bid for a price not to exceed \$30,000.00 ~~\$15,000.00~~ ("Contract Price").

3. **OTHER PROVISIONS OF THE AGREEMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park
