## AN AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH ADVANCED SECURITY SOLUTIONS, INC. FOR SECURITY SERVICES AT VILLAGE PARKING STRUCTURES AND VILLAGE HALL TO CHANGE THE NOT TO EXCEED AMOUNT FOR SECURITY SERVICES PROVIDED AT VILLAGE HALL FROM \$30,000.00 TO \$55,000.00

THIS AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT (hereinafter referred to as the "Amendment") between the Village of Oak Park, an Illinois home rule municipal corporation, and Advanced Security Solutions Inc, an Illinois corporation, is entered into this \_\_\_\_\_ day of July, 2021 (collectively referred to as the "Parties").

## **RECITALS**

WHEREAS, the Parties entered into a Professional Services Agreement dated July 28, 2020 ("Agreement"); and

WHEREAS, the Parties seek to amend Section 3.1 of the Agreement pursuant to this Amendment to reflect a new total not-to-exceed amount, for security services at Village Hall, of \$55,000.00.

**NOW, THEREFORE,** in consideration of the foregoing, and the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the Parties, the Parties hereto agree as follows:

- 1. **RECITALS INCORPORATED.** The above recitals are incorporated herein as though fully set forth.
- 2. **AMENDMENT TO AGREEMENT.** Section 3.1 of the Agreement is amended by adding the underlined language and deleting the overstricken language as follows:

The Village shall compensate the Contractor for the Services in an amount not to exceed \$587,274.24 \$612,274.24 ("Contract Price"), which includes \$557,274.24 for at Village parking structures and \$30,000 \$55,000 for security services at Village Hall, on annual basis for the initial term of this Agreement. The Contractor shall be paid installments not more frequently than once each month ("Progress Payments"). Payments shall be made within thirty (30) days of receipt by the Village of a pay request/invoice from the Contractor. Payments shall be due and owing by the Village in accordance with the terms and provisions of the Local Government Prompt Payment Act, 50 ILCS 505/1 et seq., except as set forth herein.

3. **OTHER PROVISIONS OF THE AGREMENT TO REMAIN IN EFFECT.** All other terms and conditions of the Agreement shall remain in full force and effect.

4. **EFFECTIVE DATE.** This Amendment to the Agreement shall be deemed dated and become effective on the date of its execution by the Village Manager of the Village of Oak Park.
