### V. Non-Agenda Public Comment

<u>Michael Giometti:</u> Mr. Giometti provided public comment suggesting that the Village Board is on an unproductive path of not recognizing the

consequences of their actions related to public perception and topics of civil unrest.

### VI. Village Manager Reports

Village President Abu-Taleb thanked members of the Village Board for their statement of support, and thanked the community, Village Manager Cara Pavlicek and Chief of Police Ladon Reynolds. He would like to see Oak Park move forward more unified and without police brutality and fear. Village President Abu-Taleb spoke of his personal experience living in an occupied country to express his empathy for the cause of protestors. He believes reform to be a must as well as embracing the opportunity to debate reform respectfully and inclusive of peace and support of young people and all people for change. He is committed to that direction.

### A. <u>ID 20-227</u> Review of the Revised Village Board Meeting Calendars for September thru December 2020.

Village Manager Cara Pavlicek stated that meetings will be added for racial equity training and review of police forums from the August 25, 2020 Village Board agenda will be rescheduled.

## B. MOT 20-055 An Update on the Lake Street Improvements Project and Motion to Confirm or Amend the Schedule

Village President Abu-Taleb asked the Village Board to revisit the discussion regarding timing of contracts and the potential cost of delaying until the Spring. Village Engineer Bill McKenna provided an update on progress to date. Staff had been moving forward based on direction from the Village Board to start construction after Labor Day. He stated the hope was to be finished by Thanksgiving.

Village staff outlined efforts made to survey and remain in communication with affected business owners to evaluate the best timeline for all involved and original consensus was provided that delaying construction to labor day and to finish by Thanksgiving so that next year would be construction free was preferred. If delayed until Spring 2021 construction costs would be higher, contracts would be broken and could have financial consequences, and construction would negatively interrupt business for next summer.

Village Engineer Bill McKenna clarified the extent of the work, stating that beside for approximately 5 feet of walkway the entire street will be torn up. Mr. McKenna confirmed that there is little that can be done to make the construction season shorter for either now or later. Village President Abu-Taleb asked the question of whether or not the work could be split north side versus south in order to provide some additional access. Mr.

McKenna responded, the block is too short and would make the work less efficient and add additional challenges.

The Village President and majority of Village Trustees agreed that this is a very difficult situation with no perfect response and provided consensus to remain with the original decision to begin construction and work to complete by Thanksgiving. Village Trustee Walker-Peddakotla did not agree and voted "no" to construction for the remainder of this year. All asked that staff do all they can to provide additional outdoor seating where possible and market patronage of the effected restaurants while the season allows.

### VII. First Reading

Village Manager Pavlicek introduced agenda items C., D., E., F., G., H., and I as the first reading for proposed ordinance amendments of the Oak Park Village code related to the "electric code", "building code", "existing building code", "fire code", "fuel gas code", "mechanical code", and "residential code". She explained that all ordinances would come back to the Village Board for a second and final reading before adoption.

### **C.** ORD 20-050

First Reading of An Ordinance Amending Chapter 7 ("Buildings"), Article 3 ("Electric Code") of the Oak Park Village Code to Adopt the 2017 National Electric Code as Recommended by the Building Code Advisory Commission

Director of Development Customer Services, Tammie Grossman, provided an overview of process for review of building codes and the outreach to contractors for feedback.

Chief Building Official Steven Cutaia reported that the Building Codes Advisory Commission (BCAC) and staff have been working to review and propose the ordinance changes provided recommending that the Village Board adopt the 2018 editions of the International Building Codes and the 2017 National Electric code with a decreased number of amendments to simplify and streamline the Village's building code process. Mr. Cutaia explained how codes are adopted locally versus Statewide and noted that some changes are for clarification recognizing that older codes do not address all new technology and modern advancements in building. BCAC Chair Tim Kelly explained the three year process and the commissions desire to propose as few amendments as possible. He also took the opportunity to commend staff for on-line permit application advancements which have proven to be extremely helpful during COVID-19 challenges.

Village President Abu-Taleb requested this item be removed from the consent agenda to recommend the Plan Commission consider language to the ordinance that would permit the Village Board to act as a hearing body for text amendments to the Oak Park Zoning Ordinance. He stated this action would allow them to respond to development needs in a timely manner and when circumstances are overly burdensome for the Plan Commission to consider.

Village Trustee Boutet suggested this is a different topic than the proposed motion on the agenda. She does not agree or disagree with Village President Abu-Taleb, but does believe it is a different topic from what they have before them.

Development Customer Service Director Tammie Grossman suggested staff can propose a text amendment to address the Village President's request. Village Manager Cara Pavlicek provided the history of a language change from 2017 that is in essence what the Village President is requesting the Plan Commission reconsider and provide a recommendation on how to address. Village staff can work around minor amendments and propose to Village Board outside of Plan Commission process on a case by case basis.

Village President Abu-Taleb withdrew his amendment to the discussion.

The Village Board provided direction to send the motion on the agenda to the Plan Commission; consideration of allowing service-retail uses on the ground floor of buildings in the Village's DT-downtown zoning districts pursuant to the recommendation of the Oak Park Economic Development Corporation (Oak Park EDC).
