Village Clerk Christina M. Waters administered the Oath of Office to Village President Vicki Scaman.

Outgoing Village President Anan Abu-Taleb stated that doing well and doing good are intertwined. He said we do good, when we do well. And we do well, when we do good. He provided a synopsis of the various activities and responsibilities under the Board's purview and the level of accountability required by the Board to successfully oversee these Village functions. He thanked many of the trustees he worked with over his years of service as Village President. He noted that during his term, he and the sitting Village Boards transformed the Oak Park Economic Development Corporation by making it a public/private partnership. Village Trustee Lucia Robinson expressed her gratitude in stepping into the role of Village Trustee. She shared how much Oak Park has meant to her and her family throughout the years they have lived here. In taking the oath of office, she promises to put forth the potential put forth by her campaign.
