### **Agenda Item Title**

**A Resolution Approving an Amendment to Extend the Local Public Agency Agreement for Federal Participation to Conduct Further Study of the Cap the Ike Project and Authorizing its Execution**

### **Overview**

In 2006 the Village entered into an agreement with the Illinois Department of Transportation (IDOT) for a federally funded preliminary engineering study for the original Cap the Ike preliminary engineering study which was amended in 2015 to extend the ending date of the agreement until 2019. Since IDOT has still not approved the new feasibility study for the Cap the Ike project the existing old agreement must be amended to extend the date again or the funds will be lost.

### **Recommendation**

Approve the Resolution.

### **Fiscal Impact**

There are no fiscal impacts to amending this agreement to extend the original Cap the Ike study.

### **Background**

In 2006 the Village and IDOT entered into a Local Agency Agreement for a 100% federally funded preliminary engineering study for the Cap the Ike project. In order to keep the federal funding for the Cap the Ike study the Village needs to amend this agreement a second time to extend its end date while IDOT is reviewing the agreement and scope of the feasibility study that was submitted to IDOT in December of 2017 and resubmitted in June of 2020.

### **Alternatives**

The alternative to this recommendation could be to delay action to gain additional information.

### **Previous Board Action**

On August 4, 2003 the Village Board approved an agreement with URS Corporation for a conceptual study of capping the Ike.

On April 3, 2006 the Village Board approved an agreement with the State for the current Cap the Ike study.

On May 18, 2009 the Village Board approved an agreement with URS Corporation for the current Cap the Ike Study.

On August 1, 2016 the Village Board approved a Letter of Intent (LOI) with IDOT for the I-290 Reconstruction Project.

On July 17, 2017 the Village Board Approved an Assignment and Consent Agreement with AECOM Technical Services, Inc. for the Cap the Ike Study (Bridge Decking).

On December 11, 2017 the Village Board Approved a Resolution Approving a Preliminary Engineering Services Agreement for Federal Participation with AECOM Technical Services, Inc. for a Feasibility Study of Expanded Bridge Decking over the I-290 Expressway, in an amount not to exceed \$1,314,946

On June 15, 2020 the Village Board Approved a Second Amendment to the Local Public Agency Agreement for Federal Participation for a Feasibility Study of Expanded Bridge Decking over I-290.
